



4. Remove Obstructions

The original design costs for the removal of obstructions in the 34:1 approach slope for Runway 03 was applied for prior to knowing the requirements of the Town of Hilton Head Island Land Management Ordinance (LMO) Section 16-3-404. These requirements became apparent during the preparation of the design plans for the removal of obstructions in the 34:1 approach slope for Runway 21. Tasks not anticipated include:

- <u>Detailed Tree Survey</u> locating trees according to Town of Hilton Head Island standards; showing tree size, species, and height of all located trees on South Carolina grid coordinates.
- <u>Wetland Approximation Survey</u> conducting an approximation of jurisdictional waters of the U.S., including coordinating concurrence of the jurisdictional wetlands approximation with the USACE, Charleston District Regulatory Branch.

In order to complete the design plans and obtain Town approval in accordance with LMO Section 16-3-404, the aforementioned tasks must be included as part of the design plan preparation. These tasks are labor intensive and require an amendment to the original amount allocated for the preparation of design plans (see attached, page 3).

Construction of Phase One for the referenced project was performed during the first week of October, 2011. During this construction it was discovered that an existing inlet is smaller than the 48" pipe being received. This is not standard practice and may not have been accounted for in the designer's hydraulic analysis for this project. Additionally, the angle between the entering and exiting pipe is not ideal to provide flow for water traveling through the inlet. For these reasons I recommend this existing inlet be replaced with an inlet sized large enough to accept 48" pipe. Attached are photos and a copy of plan Sheet 6 showing this inlet.

Per your request we have also enclosed our opinion of probable costs to replace the inlet. Please contact me if we may be of further assistance in this matter.







BEAUFORT COUNTY ORDINANCE NO.

AN ORDINANCE TO AMEND AND CLARIFY BEAUFORT COUNTY ORDINANCE NO. 2005/9 AND AS SUBSEQUENTLY AMENDED WITH REGARDS TO THE DEFINITION OF ESTABLISHMENTS UNDER THE BEAUFORT COUNTY LOCAL HOSPITALITY TAX

WHEREAS, Beaufort County desires to preserve the general health, safety and welfare of its residents and visitors, and

WHEREAS, Beaufort County desires to support tourism-related buildings including but not limited to parks, recreational facilities, civic centers, coliseums, aquariums, tourism-related cultural, recreational, or historical facilities, beach access and renourishment, highways, roads, streets and bridges providing access to tourist destinations, advertisements and promotions related to tourism development, water and sewer infrastructure to serve tourism-related demand, police, fire protections, emergency medical services and emergency-preparedness operations directly attendant to the foregoing facilities in order to promote and further encourage tourism in the County, and

WHEREAS, Beaufort County was authorized to enact Ordinance No. 2005/9 pursuant to S.C. Code §6-1-700 et seq., 1976, as amended; and

WHEREAS, Beaufort County Council believes that it is in the best interest of its citizens to amend and clarify a portion of Ordinance No. 2005/9 to further clarify its intent that all businesses meeting the definition of an establishment, as defined under this Ordinance, participate in the collection of local hospitality taxes.

NOW THEREFORE, BE IT ORDAINED, by the County Council of Beaufort County, South Carolina, duly assembled and by the authority of the same does hereby amend a portion of Chapter 66 the following:

Sec. 66-532. - Hospitality tax-Definitions.

(a) Local hospitality tax is a tax imposed within the unincorporated areas of Beaufort County on the sales of prepared meals and beverages sold in establishments or sales of prepared meals and beverages sold in establishments licensed for on-premises consumption of alcoholic beverages, beer, or wine. In addition, the tax shall be imposed for all food and beverages prepared or modified by convenience stores or grocery stores within the unincorporated areas of Beaufort County.

(b) A hospitality tax equal to two percent is hereby imposed on the gross proceeds derived from the sale of prepared meals and beverages sold in establishments located in unincorporated areas of Beaufort County.

(c) Beverages shall include all beverages, including, but not limited to, alcoholic beverages, beer, wine, and any nonalcoholic beverage.

(d) Establishments shall mean any individual, partnership, corporation or business entity, regardless of form which, as a part of its business offers prepared meals, for sale to the general public-whether for consumption on the premises or off.

(e) Establishments licensed for on-premises consumption of alcoholic beverages, beer or wine shall mean any individual, partnership, corporation or business entity, regardless of form, which is licensed by the State of South Carolina alcoholic beverage commission to offer alcoholic beverages, beer or wine for sale or consumption on its premises.

(f) Gross sales price shall mean the total charge for any prepared meal or beverage, exclusive of any other taxes, fees or gratuity.

(g) Prepared meals shall mean any prepared food item prepared or offered for sale by any establishments or establishments licensed for on-premises consumption of alcoholic beverages, beer or wine, whether consumed on the premises or off.

ORDINANCE NO. 2012/____

AN ORDINANCE AUTHORIZING THE ISSUANCE AND SALE OF A NOT TO EXCEED \$6,000,000 GENERAL OBLIGATION BOND, SERIES 2012B, OR SUCH OTHER APPROPRIATE SERIES DESIGNATION, OF BEAUFORT COUNTY, SOUTH CAROLINA; FIXING THE FORM AND DETAILS OF THE BOND; AUTHORIZING THE COUNTY ADMINISTRATOR TO PRESCRIBE CERTAIN MATTERS RELATING TO THE BOND; PROVIDING FOR THE PAYMENT OF THE BOND AND DISPOSITION OF THE PROCEEDS THEREOF; AND OTHER MATTERS RELATING THERETO.

BE IT ORDAINED BY THE COUNTY COUNCIL OF BEAUFORT COUNTY, SOUTH CAROLINA, AS FOLLOWS:

SECTION 1. Findings and Determinations. The County Council (the "Council") of Beaufort County, South Carolina (the "County"), hereby finds and determines:

(a) Pursuant to Section 4-9-10, Code of Laws of South Carolina 1976, as amended, and the results of a referendum held in accordance therewith, the Council-Administrator form of government was adopted and the Council constitutes the governing body of the County.

(b) Article X, Section 14 of the Constitution of the State of South Carolina, 1895, as amended (the "Constitution"), provides that each incorporated municipality shall have the power to incur bonded indebtedness in such manner and upon such terms and conditions as the General Assembly shall prescribe by general law. Such debt may be incurred only for a public and corporate purpose in an amount not exceeding eight percent of the assessed value of all taxable property of such incorporated municipality.

(c) Pursuant to Title 4, Chapter 15 of the Code (the same being and hereinafter referred to as the "County Bond Act"), the governing bodies of the several counties of the State may each issue general obligation bonds to defray the cost of any authorized purpose and for any amount not exceeding its applicable constitutional limit.

(d) The County Bond Act provides that as a condition precedent to the issuance of bonds an election be held and the result be favorable thereto. Title 11, Chapter 27 of the Code of Laws of South Carolina 1976, as amended, provides that if an election be prescribed by the provisions of the County Bond Act, but not be required by the provisions of Article X of the Constitution, then in every such instance, no election need be held (notwithstanding the requirement therefor) and the remaining provisions of the County Bond Act shall constitute a full and complete authorization to issue bonds in accordance with such remaining provisions.

(e) The assessed value of all the taxable property in the County as of June 30, 2011, is \$1,823,808,541. Eight percent of the assessed value is \$145,904,683. As of the date hereof, the outstanding general obligation debt of the County subject to the limitation imposed by Article X, Section 14(7) of the Constitution is \$93,385,369. Thus, the County may incur \$52,519,314 of additional general obligation debt within its applicable debt limitation.

(f) It is now in the best interest of the County for the Council to provide for the issuance and sale of a not exceeding \$6,000,000 principal amount general obligation bond of the County, the proceeds of which will be used to construct and equip the St. Helena Island Branch Library to be located on property leased from the Penn Center in the vicinity of Penn Center Road, St. Helena Island, South Carolina.

(g) Pursuant to the terms and conditions of Letter of Conditions addressed to the County dated September 24, 2010, and a Loan Resolution adopted by the County Council on December 13, 2010, the County Administrator has heretofore executed the necessary documents, including the Loan Resolution. to sell the Bond to The United States of America, acting through the United States Department of Agriculture (the "Federal Government") and the County Council authorized such actions pursuant to Ordinance No. 2010/25 duly enacted on December 13, 2010.

SECTION 2. Authorization and Details of Bond. Pursuant to the aforesaid provisions of the Constitution and laws of the State, there is hereby authorized to be issued a not to exceed \$6,000,000 general obligation bond of the County to be designated "\$6,000,000 (or such lesser amount issued) General Obligation Bond of Beaufort County, " (the "Bond") for the purpose stated in Section 1(f) of this Ordinance.

The Bond shall be issued in fully registered form, shall be registered as to principal and interest in the name of the Federal Government; shall be dated as of the date of its delivery; shall be in the denomination of its par amount; shall be payable by electronic debit through the preauthorized debit payment process to the Area Office of Rural Development of the United States Department of Agriculture ("Rural Development") in Walterboro, South Carolina, or at such other place or to such other fiscal agent as the Federal Government shall designate; and shall bear interest from its date at the rate of not to exceed four percent (4%) per annum.

The County shall have the option to prepay the Bond in whole or in part at any time prior to maturity without penalty.

The Bond shall be executed in the name of the County with the manual or facsimile signature of the Chairman of the County Council attested by the manual signature of the Clerk to County Council under the seal of the County to be impressed or affixed thereon.

<u>SECTION 3.</u> Form of Bond. The Bond and the provisions for registration to be endorsed thereon shall be in substantially the form attached hereto as Exhibit A and incorporated herein by reference.

SECTION 4. Security for the Bond. The full faith, credit and taxing power of the County are hereby irrevocably pledged for the payment of the principal of and interest on the Bond as they respectively mature, and for the creation of such sinking fund as may be necessary therefor. The County Auditor and the County Treasurer shall be notified as to the delivery and payment of the Bond and is hereby directed to levy and collect annually, on all taxable property in the County, an ad valorem tax, without limitation as to rate or amount, sufficient to pay the principal of and interest on the Bond as they respectively mature and to create such sinking fund as may be necessary therefor.

SECTION 5. Defeasance. The obligations of the County under this Ordinance and the pledges, covenants and agreements of the County herein made or provided for, shall be fully discharged and satisfied as to any portion of the Bonds, and such Bond or Bonds shall no longer be deemed to be outstanding hereunder when:

(a) such Bond or Bonds shall have been purchased by the County and surrendered to the County for cancellation or otherwise surrendered to the County and is canceled or subject to cancellation by the County; or (b) payment of the principal of and interest on such Bonds either (i) shall have been made or caused to be made in accordance with the terms thereof, or (ii) shall have been provided for by irrevocably depositing with a corporate trustee in trust and irrevocably set aside exclusively for such payment, (1) moneys sufficient to make such payment, or (2) Government Obligations (hereinafter defined) maturing as to principal and interest in such amounts and at such times as will ensure the availability of sufficient moneys to make such payment and all necessary and proper fees, compensation and expenses of the corporate trustee. At such time as the Bonds shall no longer be deemed to be outstanding hereunder, such Bonds shall cease to draw interest from the due date thereof and, except for the purposes of any such payment from such moneys or Government Obligations, shall no longer be secured by or entitled to the benefits of this Ordinance.

"Government Obligations" shall mean any of the following:

- direct obligations of the United States of America or agencies thereof or obligations, the payment of principal or interest on which, in the opinion of the Attorney General of the United States, is fully and unconditionally guaranteed by the United States of America;
- (ii) non-callable, U. S. Treasury Securities State and Local Government Series ("SLGS"); and
- (iii) general obligation bonds of the State, its institutions, agencies, school districts and political subdivisions.

SECTION 6. Notice of Initiative and Referendum; Notice of Private Sale. The Council hereby delegates to the Mayor the authority to determine whether the Notice prescribed under the provisions of Section 5 of Title 11, Chapter 27 of the Code relating to the initiative and referendum provisions contained in Title 5, Chapter 17 of the Code shall be given with respect to this Ordinance and any and all other notices required by law including the Notice of Private Sale required by Section 11-27-40, Code of Laws of South Carolina 1976, as amended. If said Notice is given, the Mayor is authorized to prescribe the form of the Notice and cause such Notice to be published in a newspaper of general circulation in the County, such notice in the form attached hereto as Exhibit B.

SECTION 7. Exemption from State Taxes. Both the principal of and interest on the Bond shall be exempt, in accordance with the provisions of Section 12-2-50 of the South Carolina Code, from all State, county, municipal, school district, and all other taxes or assessments, except estate or other transfer taxes, direct or indirect, general or special, whether imposed for the purpose of general revenue or otherwise.

SECTION 8. Deposit and Use of Proceeds. The proceeds derived from the sale of the Bond shall be disbursed by Rural Development at such time and from time to time as it is requested to do so by the County pursuant to a requisition for same.

SECTION 9. Tax Covenants. The County hereby covenants and agrees with the holders of the Bonds that it will not take any action which will, or fail to take any action which failure will, cause interest on the Bonds to become includable in the gross income of the holders of the Bonds for federal income tax purposes pursuant to the provisions of the Code and regulations promulgated thereunder in effect on the date of original issuance of the Bonds. The County further covenants and agrees with the holders of the Bonds that no use of the proceeds of the Bonds shall be made which, if such use had been reasonably expected on the date of issue of the Bonds would have caused the Bonds to be "arbitrage bonds," as defined in Section 148 of the Code, and to that end the County hereby shall:

(a) comply with the applicable provisions of Sections 103 and 141 through 150 of the Code and any regulations promulgated thereunder so long as the Bonds are outstanding;

(b) establish such funds, make such calculations and pay such amounts, in the manner and at the times required in order to comply with the requirements of the Code relating to required rebates of certain amounts to the United States; and

(c) make such reports of such information at the time and places required by the Code.

SECTION 10. Filings with Central Repository. In compliance with Section 11-1-85 of the South Carolina Code, the County covenants that it will file or cause to be filed with a central repository for further availability in the secondary bond market when requested: (a) a copy of the annual audit of the County within thirty (30) days of the County's receipt thereof; and (b) within thirty (30) days of the occurrence thereof, relevant information of an event which, in the opinion of the County, adversely affects more than five (5%) of the County's revenue or its tax base.

SECTION 11. Miscellaneous. The County Council hereby authorizes the County Administrator, Chair of the County Council, the Clerk to the County Council and County Attorney to execute such documents and instruments as necessary to effect the issuance of the Bonds. The County Council hereby retains McNair Law Firm, P.A., as bond counsel in connection with the issuance of the Bonds. The County Administrator is authorized to execute such contracts, documents or engagement letters with such parties as may be necessary and appropriate.

SECTION 12. Repeal of Conflicting Ordinances. All orders, resolutions, ordinances and parts thereof, procedural or otherwise, in conflict herewith or the proceedings authorizing the issuance of the Bond are, to the extent of such conflict, hereby repealed and this Ordinance shall take effect and be in full force from and after its passage and approval.

SECTION 13. Codification. This Ordinance shall be forthwith codified in the Code of County Ordinances in the manner required by law.

Equal annual installments of principal and interest on this Bond in the amount of) shall be payable commencing one year after its delivery date and (\$ continuing on the same day of each year thereafter, until this Bond is paid. Such installments shall be applied first to the payment of interest on the principal amount hereof from time to time unpaid and then to the payment of principal as a principal installment hereon; provided that the final payment, if not sooner paid, shall be due and pavable 40 years from the date hereof and shall be an amount equal only to the principal amount hereof then unpaid plus the interest accrued thereon to the date of such final payment, notwithstanding that such amount is more or less than \$

Both the principal of and the interest on this Bond shall be paid by electronic debit through the preauthorized debit payment process to the registered owner hereof. Payment and prepayment of the principal installments and interest due hereon shall be payable to the Federal Government at the Area Office of Rural Development of the United States Department of Agriculture ("Rural Development") in Walterboro, South Carolina, or at such other place or to such other fiscal agent as the Federal Government shall designate, and, except for the final payment of the principal hereof, shall be made without presentation and surrender by the Federal Government of this Bond. Such payment and prepayment shall fully discharge the obligation of the County to the extent of the payments and prepayments so made.

The County reserves the right to redeem this Bond at its option in whole at any time or in part at any time and from time to time, provided, however, that any such payment of principal upon redemption shall be accompanied by the interest accrued on the Bond to the date fixed for redemption. There shall be no premium paid by the County upon any redemption of this Bond.

For the payment hereof, both principal and interest, as they respectively mature; and for the creation of a sinking fund to aid in the retirement and payment thereof the full faith, credit and taxing power of the County are irrevocably pledged, and there shall be levied and collected, annually upon all taxable property in the County an ad valorem tax, without limitation as to rate or amount, sufficient for such purposes.

This Bond is issued pursuant to and in accordance with the constitution of the laws of the state of South Carolina, including Article X, Section 14 of the Constitution of the State of South Carolina, 1895, as amended; Title 4, Chapter 15, Code of Laws of South Carolina 1976, as amended; and Ordinance No. _____ duly enacted on ______, 2012, by the County Council of the County for the purpose of authorizing the issuance and sale of a not to exceed \$60,000,000 general obligation bond.

The County hereby certifies that it is unable to obtain sufficient credit elsewhere to finance its actual needs at reasonable rates and terms, taking into consideration prevailing private and cooperative rates and terms in or near its community for loans for similar purposes and periods of time.

If at any time it shall appear to the Federal Government that the County may be able to obtain a loan from a reasonable cooperative or private credit source at reasonable rates and terms for loans for similar purposes and periods of time, the County will, at the Federal Government's request, apply for and accept such loan in sufficient amount to repay the Federal Government.

This Bond is given as evidence of a loan to the County made by the Federal Government pursuant to the Consolidated Farm and Rural Development Act and shall be subject to the present regulations of the Federal Government and to its future regulations not inconsistent with the express provisions hereof.

This Bond and the interest hereon are exempt from all State, county, municipal, school district and all other taxes or assessments, direct or indirect, general or special, whether imposed for the purpose of general revenue or otherwise, except inheritance, estate or transfer taxes.

It is hereby certified and recited that all acts, conditions and things required by the Constitution and laws of the State of South Carolina to exist, to happen and to be performed precedent to or in the issuance of this Bond exist, have happened and have been performed in regular and due time, form and manner as required by law; that the amount of this Bond, together with all other indebtedness of the County does not exceed the applicable limitation of indebtedness under the laws of the State of South Carolina; and that provision has been made for the levy and collection annually upon all taxable property in the County an <u>ad valorem</u> tax, without limitation as to rate or amount, sufficient to pay the principal and interest on this Bond as the same shall respectively mature and to create a sinking fund to aid in the retirement and payment thereof.

BACKGROUND. PFC Programs provide a means to generate funds to help pay for airport capital improvements. They do so by applying a \$4.50 per ticket surcharge for passengers departing from the airport. FAA review and approval is required for implementation. The Hilton Head Island Airport has had PFC Programs in the past, but currently does not have one in place. This new PFC Program will be used to generate revenue to reimburse the County's cost for previously completed airport capital improvements and to fund the Airport's 2.5% matching share for future capital improvements as recommended in the recent Master Plan Update. A total of 22 projects have been identified for funding with a combined total cost of \$2,711,322.00. Based on current and forecast enplanement figures, this revenue will need to be collected over a 10 ½ year period. The Airports Board favorably endorses the establishment of a new PFC program for the Hilton Head Island Airport.

FUNDING. PFC Programs are designed to generate revenue for airport capital improvement projects.

<u>RECOMMENDATION.</u> That the Finance Committee approve and recommend that County Council approve the establishment of a new PFC Program for the Hilton Head Island Airport as described in the attached presentation.

Beaufort County has received notice from the Town of Port Royal of its intentions to hold a public hearing for the purposes of establishing the Seaport Tax Increment Financing District ("TIF"). Pursuant to South Carolina Code of Laws Section 31-6-80, Beaufort County must respond in writing by the date of the public hearing, February 8, 2012, of its intentions to not participate in the TIF or the County will be deemed to consent to the creation of the District by its silence.

Administrative staff for the County has reviewed the Seaport Redevelopment Plan that has been submitted by the Town of Port Royal and which forms the foundation for the creation of the TIF. Upon review of the Redevelopment Plan, staff recommends approval of the creation of the TIF. The grounds for providing this recommendation are that the properties which form the significant majority of the TIF are all currently exempt from taxation as they are owned by State of Local governments. Therefore, the County is currently receiving a de minimus amount of revenue from these parcels. By creating the TIF, these properties will be transferred from public to private hands thus enabling them to be placed on the tax rolls and generate revenue in the future for the County and the other taxing districts involved in this project. This file is too large to include in this data package.

Discussion: Passenger Facility Charge (PFC) Programs provide a means to generate funds to help pay for airport capital improvements. They do so by applying a \$4.50 per ticket surcharge for passengers departing from the airport. FAA review and approval is required for implementation. The Hilton Head Island Airport has had PFC Programs in the past, but currently does not have one in place. This new PFC Program will be used to generated revenue to reimburse the County's cost for previously completed airport capital improvements and to fund the Airports 2.5% matching share for future capital improvements as recommended in the recent Master Plan Update. A total of 22 projects have been identified for funding with a combined total cost of \$2,711,322. Based on current and forecast enplanement figures, this revenue will need to be collected over a 10.5 year period. The Airports Board favorably endorses the establishment of a new PFC program for the Hilton Head Island Airport. PFC Programs are designed to generate revenue for airport capital improvement project.

The grounds for providing this recommendation are that the properties which form the significant majority of the TIF are all currently exempt from taxation as they are owned by state or local governments. Therefore, the county is currently receiving a de minimus amount of revenue from these parcels. to private hands thus enabling them to be placed in the tax rolls and generate revenue in the future for the county and the other taxing district is involved in this projects.

bring more money here. One of those would be to assess homes at 80% of market value to lower tax base and get more state education money.

2. Water Quality Restoration Plan

Discussion: Mr. Dan Ahern, Stormwater Utility Manager, presented a Powerpoint regarding the proposed Watershed Quality Restoration Plan (Plan). The County adopted stormwater volume controls for new and redevelopment in October 2009. The County then developed stormwater volume controls for lots of record, but not built in June of 2011. These controls complete the prevention measures needed to protect our water resources from future water use impairments according to our antidegradation goal of 10 percent equivalent impervious surface. There is now a need to focus our efforts on water quality retrofits to restore currently impaired waters.

Minutes – Natural Resources Committee January 3, 2012 Page 3 of 4

The proposed Water Quality Restoration Plan was developed to be the initial five-year action plan. Restoring currently impaired waters will require considerable investment in public funds and needs to be scheduled within allowable fiscal constraints. In this light the Action Plan is the first of many five-year plans that will address impaired waters on a watershed by watershed basis. It is proposed that unique partnerships and plans will be developed for each watershed with the goal of meeting all the designated water uses in that watershed. The Plan proposes to address two watersheds in the first 5 year plan. They will be Battery Creek and Okatie River.

The draft plan was presented to the Stormwater Utility Board in July and in final form at their December Board meeting. They passed the following resolution: "The Stormwater Utility Board approves the December 2011 Water Quality Restoration Plan and recommends that the Utility takes action to initiate implementation".

Actions needed to restore watersheds will be funded with Stormwater Fees and any additional funding that can be obtained through grants. There are many variables in developing cost estimates and this will be an evolving plan. Completion of all proposed regional retrofits and funding of incentives within the watershed would cost an estimated \$5,600,000 over the five year program with most of the cost in FY 2014 and 2015. Consideration of a SW Fee increase may be necessary to complete within the 5 year timeframe. Funding program within the current rates would fund two of the four priority retrofits (one each in Battery Creek and Okatie River) and would cost \$2,400,000 over the 5 year program.

Mr. Reed Armstrong, with the Coastal Conservation League, spoke to the Committee and praised the Plan. He also said restoration projects are under way to improve runoff from Boundary Street, from US Highway 278 and on the bridge over the Okatie River. Form-based code will also be effective in improving water quality.

Motion: It was moved by Ms. Von Harten, seconded by Mr. Flewelling, that the Natural Resources Committee recommends Council approve the Water Quality Restoration Plan. The vote was: FOR – Mr. Baer, Mr. Caporale, Mr. Dawson, Mr. Glaze, Mr. McBride, Mr. Sommerville and Ms. Von Harten. The motion passed.

Recommendation: Council approve the Water Quality Restoration Plan.

3. Discussion / A Private – Public Venture Policy for Beaufort County for use on Properties Acquired Through the Rural and Critical Lands Preservation Program

Discussion: A draft policy was presented on management policies regarding Rural and Critical Lands park property. Standards and criteria have been reviewed. Mr. Criscitiello, Division-Director Planning and Development, will bring a pilot project forward next month. He

said the Planning Department is not qualified to manage the properties and staff needs guidance on this. The policy/resolution was discussed and some small adjustments were made.

Mr. Flewelling wants the Planning Board to review the proposal and the committee appeared to agree. It was noted that the plan does not include Parks and Leisure Services (PALS) parks, nor are any responsibilities required of PALS. Also, the policy will include: "It is the policy of County Council that these (parks) will be self supporting."

Mr. Criscitiello will come back with a specific proposal in two weeks. He would like to have an approved policy today to take to Finance Committee and then bring a model program back to the committee for consideration.

Mr. David Tedder, a lawyer, spoke about the policy regarding 'for profit' and 'not for profit' contracts. He recommends all proposals be approved by Council. That language should be added to 'standards' section. He made a few other grammatical changes in accordance with the committee's expressed wishes.

Main motion: <u>It was moved by Mr. Flewelling</u>, seconded by Mr. Baer, that the Committee recommend Council adopt a resolution outlining the policy of Beaufort County with regards to public-private ventures for use on properties acquired through the Rural and Critical Land Preservation Program and to present the policy at the next Finance Committee meeting.

Motion to amend by addition: It was moved by Ms. Von Harten, seconded by Mr. Flewelling, that Mr. David Tedder's suggestions be included into the policy. The vote was: FOR – Mr. Baer, Mr. Caporale, Mr. Dawson, Mr. Glaze, Mr. McBride, Mr. Sommerville and Ms. Von Harten. The motion passed.

Joint Staff Recommendation:

To maintain the existing priority moving forward with US 278 frontage Roads, SC 170 (Phase I) and Boundary Street within the existing financial constraints. As the State Infrastructure Bank may make an allocation towards the SC 170 project, the next priority project, Bluffton Parkway 5A Fly-Over Bridge, may possibly commence.
