#### PUBLIC COMMENT

The Chairman recognized Ms. Moreen Korzik, Executive Director, and Mr. Caesar Garcia, Beaufort Area Coordinator, of Second Helpings, a non-profit agency committed to fighting hunger in Beaufort County. Last year we distributed almost 2.7 million pounds of food to 65 agencies throughout Beaufort County. We have the most impact in Beaufort County insofar as hunger is concerned.

Rev. Venus Young, a resident of Seabrook, stated the Stuart Point area is in need of public water and public water access. Several recent fires have required gallons of water to be trucked into the neighborhood. Please consider public water in the Stuart Point area as a Community Development Block Grant needs assessment priority.

Mr. John Payne, representing the Military Enhancement Committee, stated the Committee's purpose is to ensure we do not lose any of our three military installations in Beaufort County. He is concerned about the proposed text amendment to the Zoning and Development Standards Ordinance, Article V. Use Regulations, Sec. 106-1287. Commercial Retail, Regional (adds standards to allow adaptive re-use of light industrial properties. The change, if approved, would allow a much larger area for development. We are here to protect tomorrow, not today.

Mr. David Tedder, legal counsel for Beaufort Liquidators, stated the proposed text amendment to the Zoning and Development Standards Ordinance to allow adaptive re-use of light industrial properties is not a change to the Air Installations Compatible Use Zones (AICUZ). It is a change to the underlying text. It does not open up a large area for development. It is strictly constrained to an area in the limited industrial area within 1,000 feet of a major arterial road.

#### **MCAS Beaufort Noise Impact Presentation**

Mr. Fred Pierson, Program Manager, Mission Compatibility Office, NAVFAC Atlantic, gave a PowerPoint presentation on the Air Installations Compatible Use Zones (AICUZ), Noise and Development. The goals of the AICUZ program are to protect the health, safety and welfare of those living near the air station as well as to ensure the continuing flight mission of the installation. It is non-binding and provides recommendations to communities for compatible development. Sound is defined as compression waves transmitted through a medium such as air, sound becomes noise when it is unwanted, and noise is in the hearing of the beholder. Sound is measured in decibels using a logarithmic scale. Noise is influenced by changes in the power setting, height above ground, terrain, type of surface (forests, farmlands, water), and orientation of the aircraft.

#### COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) NEEDS ASSESSMENT TO SOLICIT PUBLIC INPUT ON COMMUNITY NEEDS AND PRIORITIES FOR HOUSING, PUBLIC FACILITIES, AND ECONOMIC DEVELOPMENT

Mrs. Michelle Knight, Community & Economic Development Director, stated the public hearing is required to solicit public comment on the S.C. Community Development Block Grant Program (CDBG) for Beaufort County. This will put the County in a position to be able to pursue CDBG funding for the coming year.

Mrs. Knight gave a PowerPoint presentation on the S.C. Community Development Block Grant Program (CDBG). CDBG Program is designed to assist units of local government in improving economic opportunities and meeting community revitalization needs, particularly for a person of low-and-moderate income (LMI). The program has been funded through the State since 1982 by the U.S. Department of Housing and Urban Development under Title I of the Housing Community Development Act of 1974. The annual allocation from HUD for the program is administered by the S.C. Department of Commerce, Division of Grant Administration.

South Carolina has been allotted approximately \$19,333,299 CDBG funds for 2014. This allocation has been divided among the program as follows: (i) Community Development Programs \$16,153,302 – Community Infrastructure \$7,753,302, Community Enrichment \$1,800,000, Neighborhood Revitalization \$6,000,000 and "Ready to go" Public Facilities Program \$600,000. (ii) Business Development Programs \$2,000,000 – Regional Planning Program \$500,000, State Technical Assistance (1%) \$193,332 and State Administration (2% of allocation + \$100,000) \$486,665.

All projects have to meet one of three national objectives: benefit low and moderate-income persons, aid in the prevention or elimination of slums or blight and meet other urgent community needs posing a serious threat to the health or welfare of the community, where other financial resources are not available to meet such needs. In Beaufort County, a low-to-moderate income household of four person household for this year, if the annual income was less than \$53,600 a year, would be a low-to-moderate income household.

As a part of the requirements of the CDBG program, the locality (Beaufort County) is expected to undertake activities that promote Fair Housing, Title VIII of the Civil Rights Act of 1968 stipulates that we all have the right to be treated fairly regardless of our race, color, religion, sex, familial status, or origin.

Application request deadlines: March 14, 2014 at 5:00 p.m. for Community Infrastructure; August 15, 2014 at 5:00 p.m. for Community Enrichment and Neighborhood Revitalization; "Ready to Go" and Business Development Projects are due 30 days after a request is made.

Matching fund requirements for all projects are now 10% of the grant request. However, additional leveraging for Community Development projects will make your project more competitive.

After calling once for public comment, the Chairman recognized Mr. Steve Curless, a resident of Beaufort, who said Club Bridge Road, just beyond Renn Center, is narrow, busy and bicyclists and pedestrians are forced to walk on the edge of the road or grass. Please consider sidewalk installation between Club Bridge Road and US Highway 21.

Mrs. Angel Flewelling, a resident of Battery Point subdivision, which is located at the end of Salem Road in Beaufort, is here today to advocate for a sidewalk along Salem Road. There are several low-to-income housing developments along that road. She travels up and down that road an average of four times a day. Every time she goes down that road, she sees a pedestrian, a stroller, or a wheelchair. This is a safety hazard. Please consider sidewalk installation along Salem Road.

Mr. Gary Kubic, speaking on behalf of Rev. Venus Young, asked the Clerk to Council to incorporate Rev. Young's prior remarks during public comment for this public hearing. Rev. Young referred to public water and public water access in the Stuart Point community, which is

south of the Whale Branch River, is needed. It does qualify as a low-and-moderate income sector of our community. For all of the obvious reasons, it is time, perhaps, to address the utilization of these community block grant funds for the installation of water lines which improves the quality of life to all the residents there who are currently on well water.

Rev. Venus Young, a resident of Seabrook, stated the Stuart Point area is in need of public water and public water access. Several recent fires have required gallons of water to be trucked into the neighborhood. Please consider public water in the Stuart Point area as a Community Development Block Grant needs assessment priority.

After calling twice more for public comment and receiving none, the Chairman declared the hearing closed at 6:32 p.m.

An Ordinance to Establish a General Fund Reserve Policy for Beaufort County, South Carolina

**Discussion:** Committee Chairman Rick Caporale provided the Committee an overview of historical discussions regarding the establishment of a General Fund Reserve Policy for Beaufort County. The current reserve is approximately 25%. The proposed ordinance, if approved, would require an increase to 40%. Mr. Caporale feels 25% to 33% a reasonable amount to have in reserves, and feels an ordinance is an appropriate avenue of establishing the policy.

Mr. Fobes stated he is in agreement with Mr. Caporale, but has many questions. Where will we be in the future to pay debt on operations? It is hard to nail down a reserve policy without those numbers. He is not a fan of five months of reserves. Three to four months is more realistic. He favors adopting the reserve policy by ordinance.

Mr. Vaux stated he is in favor of three to four months of reserves. He supports adopting the reserve policy as an ordinance.

Mr. McBride feels the Reserve Policy should be established by ordinance. He also feels 33% is a good starting point.

Mr. Flewelling stated he favors a four-month carry capacity of 33%. He also feels it appropriate to consider a tax increase to replace reserve dollars in the years revenues do not exceed expenditures.

Mr. Stewart feels establishment by way of ordinance to be a good approach. He also feels the need for 35% in reserves.

Mr. Dawson feels a four-to-five month reserve balance is appropriate. He supports adopting the reserve policy as an ordinance.

Ms. Von Harten would like to see a five month reserve. She supports adopting the reserve policy as an ordinance.

Mrs. Bensch spoke about GFOA and their overview of this matter. They recommend no less than 5% to 10% or one to two months of reserves. Many people are taking into consideration the economy and not raising taxes. She would like to be conservative on this amount and would only support an ordinance if it were extremely conservative. She does not support the proposed ordinance. She spoke about three-sub reserves in detail and the possibility of that type of idea for reserves. She would like to use a dividing scale and feels it would keep Council from going to the taxpayers asking for a tax increase. It should not be a blanket ordinance, and should be broken down by the different types of reserves or purposes of use.

County Administrator Gary Kubic spoke to the Committee. He looks forward to having an ordinance to define the fund balance. He recommends not focusing on a reserve policy for an AAA rating, but looking at it as a management tool. He is not concerned as to the level or the formula because he knows Council will decide annually what is needed for the citizens of Beaufort County. He asked Council to reach a consensus. It can be reviewed periodically and modified.

Questions from the Committee included:

How much are we going to borrow? How much will AAA bond rating save? What additional taxation might be required to maintain a fund balance? Minutes - Finance Committee February 3, 2014 Page 3 of 3

#### ORDINANCE NO.

#### AN ORDINANCE TO AMEND SECTIONS 2-509 AND 2-512 OF THE BEAUFORT COUNTY CODE OF ORDINANCES SO AS TO EFFECT CHANGES TO THE BEAUFORT COUNTY PURCHASING ORDINANCE

**WHEREAS,** Beaufort County is required to adopt competitive purchasing policies pursuant to South Carolina Code of Laws Section 11-35-50; and

**WHEREAS,** certain requirements and limitation contained within Beaufort County's Purchasing Ordinance have not been updated since the year 1999; and

WHEREAS, general increases in costs as well as the rate of economic inflation have created administrative inefficiencies in terms of contracting for goods and services thereby necessitating changes to the County's Purchasing Ordinance; and

WHEREAS, the constitutionally elected and appointed officials within Beaufort County have inherent authority to contract for goods and services so long as they remain compliant with all necessary competitive procurement regulations and do not exceed their annual fiscal appropriations provided to them by County Council; and

**WHEREAS,** it is now in the County's best interests to update its Purchasing Ordinance to reflect these changes.

**NOW, THEREFORE, BE IT ORDAINED** by Beaufort County Council that Sections 2-509 and 2-512 of the Beaufort County Purchasing Ordinance are hereby amended as follows:

NOTE: <u>Underlined and bold-face typed</u> portions indicate additions to the County Code. Stricken portions indicate deletions to the County Code.

#### Sec. 2-509. Authority and duties of purchasing director.

- (a) *Principal public procurement official.* The purchasing director shall serve as the principal public procurement official of the county and shall be responsible for the procurement of supplies, services, and construction in accordance with this division, as well as the management and disposal of supplies.
- (b) *Duties.* In accordance with this division, the purchasing director shall:
  - (1) *Purchase*. Purchase all supplies, materials, equipment, and contractual services required by county agencies and perform the purchasing-related functions required of the purchasing director in this division.

- (2) *Negotiate contracts.* Negotiate contracts for personal services and submit them for approval and award as provided in this division.
- (3) *Use standard specifications.* Use standard specifications wherever they are applicable to purchase orders and contracts, and ensure compliance with such specifications through adequate inspection of deliveries.
- (4) *Transfer between agencies*. Transfer between agencies supplies, materials, and equipment that are no longer needed by a holding agency but that can be used by the receiving agency.
- (5) *Exchange, trade in and sell.* Exchange, trade in or sell those supplies, materials and equipment which are surplus, obsolete or unused and which are found by the county administrator not to be required for public use.
- (6) *Develop standard forms and conditions.* Develop, with the approval of the county attorney as to legal sufficiency, standard forms and conditions of invitations to bid and purchase orders and contracts; develop and prescribe the use by agencies of other forms required in carrying out this division, and amend or eliminate any such forms.
- (7) *Acquire and dispose of real property.* Upon request of the county council and subject to its approval of each transaction, perform all delegable functions in connection with acquisition and disposal of real property.
- (8) *Perform other duties.* Perform other duties as assigned by the county administrator and comptroller.
- (c) *Operational procedures.* Consistent with this division, the purchasing director shall adopt operational procedures relating to the execution of his duties.
- (d) *Dollar limitations.* Provided that funds have been preapproved by the county council as part of the budget process, an award is made to the lowest responsive and responsible bidder, the contracting authority for the county, except as otherwise provided in section 2-512 pertaining to authority to contract for certain services, section 2-513 pertaining to exemption and section 2-514 pertaining to exemption for real property, shall be as follows:
  - (1) Purchasing director or his designee, \$5,000.00 or less.

- (2) (1) Comptroller or his designee, over \$5,000.00, but less than \$10,000.00. Purchasing director, comptroller, chief financial officer, and deputy county administrator or his/her designee, \$10,000 or less.
- (3) (2) county administrator or his designee, over \$10,000.00, but less than \$25,000.00 \$50,000.00.
- (4) (3) Council committee, over \$25,000.00 \$50,000.00, but less than \$50,000.00 \$100,000.00.
- (5) (4) The county council, \$50,000.00 \$100,000.00 and over.
- (e) Elected and Appointed Officials. Provided that funds have been approved by the County Council as part of the annual budget appropriation process, and that any expenditure of funds regardless of the amount will not result in a budget deficit within any elected official's office, the Sheriff, Auditor, Treasurer, Clerk of Court, Coroner, Solicitor, Public Defender, Probate Judge, and Magistrates shall be exempt from the dollar limitations on expenditure authority identified above provided that they shall comply with all of provisions of competitive purchasing as may be required by South Carolina law and the Beaufort County Purchasing Ordinance. The County Council may request such reports and information as it deems necessary and prudent on the purchasing activities of these offices to ensure compliance with these provisions.

#### Sec. 2-512. Authority to contract for certain services.

- (a) *General authority.* Departments needing to procure the professional services of clergy, physicians, dentists or undertakers may do so on their own behalf subject to subsection 2-516(h).
- (b) *Contracts for legal services*. No contract for the services of legal counsel may be awarded without the approval of the county council <u>or the county administrator</u>.
- (c) *Auditing, consulting and other professional services.* Auditing, consulting and other professional services shall be procured in accordance with section 2-542.
- (d) *Fixed base operators, etc.* Contracts for fixed base operators and other private services operating on county airports shall be subject to the ordinance and the approval of the county council.

#### Sec. 106-1912. Water dependant uses

- (b) *Docks, piers, and wharfs.* 
  - (1) Tidal creeks and shallows are the most sensitive, ecologically, and are, therefore, being regulated.
  - (2) Small tidal creeks and shallows, which fall within the county, are defined as those bodies of water, [being tidally influenced] as per the Beaufort County official small tidal creek delineation map. Private docks and community docks in small tidal creeks may be allowed on both existing lots of record, and new subdivisions under the following criteria:
    - h. The use of docks shall be limited to private, non-commercial uses, unless allowed for it is associated with an upland property productively in use as an on-going mariculture enterprise, and in possession of a current mariculture permit issued by the state of South Carolina for the purpose of growing mollusk shellfish. Also, the use of docks on small tidal creeks dedicated to commercial fishing or shrimping is permitted as part of a Commercial Fishing Village Overlay District.
