At the request of Finance Committee Chairman, staff has provided three pieces of FY 2015 budget summary information: (i) department budget differences for fiscal years 2013, 2014 and 2015; (ii) budget ordinance categories; and (ii) revenues and expenditures effective June 30, 2011, June 30, 2012 and June 30, 2013 and fiscal year budgets 2014 and 2015.

The major difference is no additional mills on both operations and general obligation debt. To achieve a no mill increase, changes were made to the general operations side as follows:

- Monitor vacancy factor; allow the natural attrition process first and then not replace 40 to 50 positions;
- Increase reserves from \$500,000 to \$750,000 (money that may be taken back during the next fiscal year due to all of the uncertainty associated with reassessment (*Angus v. City of Myrtle Beach*));
- Restore department budgets back to FY 2014 levels

The public should assume that we are not adding to the debt schedule in the sense of additional millage. The original millage debt schedule is still intact, even though it is a slight tick up predicated on prior year borrowing. This is a timing issue.

**Discussion:** Mr. Bryan Hill, Deputy County Administrator, provided the Committee a PowerPoint Presentation on the FY 2015 Administrator's Budget proposal. The presentation included an overview of FY 2014 General Fund Revenue of \$99,436,715 (projected) and FY

2015 in the amount of \$100,029,744 (anticipated), which is a change of \$593,029. A breakdown of revenue by various categories was provided. County FY 2014 millage rates were presented to the Committee:

- Operational Millage 46.48
- County Debt 5.48
- County Purchase Property 4.34

Beaufort County FY 2014 population was 162,818. The estimated FY 2015 population is 168,016. This is a population increase of 2.27% and a growth of 1.46%. The maximum increase in millage allowed is 3.73%, which is a millage rate cap of 48.21.

The following assumptions were included in the FY 2015 budget proposal:

- Three percent (3%) vacancy factor;
- County Administrative Divisions at FY 2014 appropriation levels;
- Hiring freeze within County Administrative Divisions;
- Reduction of Convenient Center hours;
- FY 2014 supplemental appropriations set at FY 2013 levels for the following entities: Solicitor, University of South Carolina-Beaufort, Technical College of the Lowcountry, Beaufort Memorial Hospital, and Hilton Head Island Recreation Center.

The following issues have impacted the FX 2015 budget in an amount of \$1,601,279: health insurance \$1,200,000, Workers Compensation \$150,000 and retirement \$251,279 (South Carolina Retirement System \$100,296 and Police Officers Retirement System \$150,983).

The following FY 2015 budget numbers were provided to the Committee as a starting point:

- Requested budget: \$109,462,015
- Total capital request: \$4,562,210
- Capital eliminated: \$3.123,496
- Capital retained: \$1,438,714
- Three percent (3%) vacancy factor: +\$1,916,536
- Revised numbers: \$104,421,982

FY 2013 - FY 2015 contributions were presented to the Committee, as well as the budget results for FY 2015.

Staff has presented a budget where the FY 2015 General Fund appropriation level is \$100,789,461 and the FY 2015 General Fund Revenue is projected at \$100,029,744. This would require a change in millage of .46 or \$759,717.

# AN ORDINANCE TO INCREASE THE MINIMUM SALARY PAID TO BEAUFORT COUNTY MAGISTRATES BY ELIMINATING PROGRESSIVE STEP PAY INCREASES

WHEREAS, Beaufort County is required to pay newly appointed magistrates a minimum salary based upon population as outlined in South Carolina Code of Laws Sections 22-8-40(B)(1)(a) through 22-8-40(B)(1)(d); and

WHEREAS, these provisions has provided for progressive pay increases to newly appointed magistrates based upon successfully completing additional years of service and corresponding legal education requirements; and

WHEREAS, Beaufort County Council believes that it is appropriate to eliminate these progressive pay increases and pay all newly hired magistrates the full base salary outlined in South Carolina Code of Laws Section 22-8-40(B)(1)(e); and

**NOW THEREFORE, BE IT ORDAINED**, by the County Council in a meeting duly assembled:

<u>Section 1.</u> It is found and determined that each statement of fact set forth in the preamble of this ordinance (this "*Ordinance*") is in all respects true and correct.

<u>Section 2.</u> On the basis of the facts before County Council and those adduced at the public hearing held on \_\_\_\_\_\_, 2014, it is found and determined that the Fripp Island Public Service District Commission, the governing body of the District (the "*Commission*"), should be authorized to issue the Bonds.

<u>Section 3.</u> The County Council finds that the Commission should issue the Bonds in an amount of not exceeding \$1,000,000 as a single issue or from time to time as several separate issues, as the District shall determine.

<u>Section 4.</u> The County Council hereby authorizes the Commission to issue the Bonds in an aggregate principal amount of not exceeding \$1,000,000, as a single issue or from time to time as several separate issues as the Commission shall determine, in order to defray (A) the costs of constructing and equipping certain improvements to the District's wastewater treatment plant (the "*Project*"), and (B) the costs of issuance of such general obligation bonds. The Commission estimates that the cost of the Project, together with the costs of issuance of the Bonds will not exceed \$1,000,000. For the payment of the principal of and interest on the Bonds as they respectively mature, and for the creation of such sinking fund as may be necessary therefor, the full faith, credit and taxing power of the District shall be irrevocably pledged, and there shall be levied annually a tax without limit on all taxable property within the District sufficient to pay such principal of and interest on the Bonds as they respectively mature, and to create such sinking fund therefor.

<u>Section 5.</u> The Chairman and other officers of the County Council are herewith authorized and empowered to take such further action as may be necessary to fully implement the action taken by this Ordinance.

<u>Section 6.</u> A certified copy of this Ordinance shall forthwith be transmitted to the Commission to advise it of the action taken by the County Council, whereby the Commission has been authorized to issue, pursuant to the provisions of the Enabling Act, the Bonds in the aggregate principal amount of not exceeding \$1,000,000.

**BACKGROUND:** Beaufort County issued a Request for Proposals (RFP) to vendors capable of providing janitorial services for Beaufort County facilities located both North and South of the Broad River (27 facilities in the North, including additional services needed at the 14 buildings currently being serviced by Disabilities and Special Needs (DSN), and 9 facilities in the South). The intent of the RFP is to select the most qualified responsive/responsible vendor whose schedule of service, support, and price is in the best interest of Beaufort County. The scope of services will require the selected contractor to provide a complete and efficient janitorial service, including all reasonable and necessary labor, supervision, equipment, licenses, insurance, and supplies to keep the contracted areas clean and properly supplied.

The evaluation committee consisted of the following six members: Missy Easler, Fiscal Technician; Alan Eisenman, Financial Supervisor; Scott Marshall, Parks and Leisure Services Director; Jon Rembold, Airports Director; Mark Roseneau, Director of Facilities Management; and Wlodek Zaryczny, Library Director. Dave Thomas, Purchasing Director, facilitated the process and provided guidance to the evaluation committee. Monica Spells, Compliance Officer, observed all committee meetings. On March 5, 2014, Beaufort County received sixteen responses to the RFP (Attachment 1 "Final Ranking and Cost Sheet"). The evaluation committee evaluated all responses based on the selection criteria and short-listed the following five vendors for interviews: 360 Clean, A&B Cleaning Service, Beaufort Janitorial, The Budd Group, and Defender Services. The evaluation committee completed interviews on April 9, 2014 and requested "Best and Final Offers" from these five vendors with a response date of April 24, 2014. After review of the "Best and Final Offers" and consideration of the RFP evaluation criteria scoring, the panel selected A & B Cleaning Service as the number one ranked vendor to provide janitorial services for County facilities North and South of the Broad River.







**BACKGROUND.** Beaufort County issued a Request for Proposals from qualified firms to design and build the Dirt Road Paving Contract #48. The following two firms responded and provided proposals for the project on 1/30/14.

The Design-Build proposal process differs from a typical construction bid, in that the proposers outline how they would accomplish the project within a specified cost. In this regard, proposals are reviewed on the basis of the "value offered" raher than solely on the lowest price. A committee consisting of the Director of Engineering and Infrastructure, Engineering Construction Manager, General Support Superintendent, and one County Transportation Committee member reviewed the proposals and interviewed the teams from BES Incorporated and Cleland Site Prep LLC.

After the interviews, BES Incorporated with Andrews & Burgess, Inc. and J.H. Hiers Construction was selected as the proposer providing best value for the design and construction of this project. This team's proposal was also reviewed for compliance with the County's Small & Minority Business Subcontractor Guidelines. It has been determined that they made a "Good Faith Effort" and are in compliance with respect to Beaufort County's requirements regarding the Small & Minority Business Subcontractor Guidelines.

On the basis of the qualification of the firm and the value offered, the committee recommends award of a design/build contract to BES Incorporated/Andrews & Burgess. The project will be funded by BCTC funds with an available fund balance at 5/1/14 of  $\pm$ \$1.8 million and anticipated C Fund distribution from SCDOT for the remaining FY 2014 at approximately \$385,000.

**BACKGROUND**. Major Road is a County maintained dirt road located on Warsaw Island connecting to Warsaw Island Road. Public Works has maintained the 0.3 mile dirt road for over 20 years. Major Road was selected for paving by the Beaufort County Transportation Committee on 8/21/13 for the FY13/14-FY 16/17 Dirt Road Paving Program.

In accordance with Section 106.2797 of the ZDSO and Policy Statement 17, the County should have deeded 50-foot right of way for any dirt road before it can be included in a paving contract.

Efforts to date to obtain signed deeds for Major Road include obtaining a cost for survey, initiating a survey agreement, performing the field survey, researching ownership, preparing letters and deeds, and providing time for owner consideration and questions or discussions. The timeline associated with the process has been approximately seven months. Although the County does not own right of way for this road, every plat for the parcels adjacent to Major Road show that the road is separate from the individual parcels. The independent survey verified all property corners and property lines relative to the layout of Major Road and no real property is needed from any of the adjacent parcels. Since no deed currently exists for the Major Road right of way, staff is required to request that all adjacent parcel owners deed to the County any interest which they might have in the road in order to complete improvements.

Engineering has received fourteen of the sixteen signed right of way deeds needed. The remaining one owner had 2 parcels titled in his name, is deceased, with his wife recently passing away. Condemnation of these 2 remaining parcels would be necessary to obtain a valid deed and complete the total right of way acquisition effort for Major Road. All of the other property owners have provided overwhelming support for this project.


Engineering and Public Works Departments are therefore presenting this information for committee review and are recommending that the remaining two parcels on Major Road for right-of-way acquisition be condemned.

Gentlemen:

I want to thank both of you and your staffs for the assistance and cooperation in the recently concluded action last year to close and abandon Ihly Road not only on behalf of my client, Clarendon Farms, but for myself as well. The responses and assistance were expeditious, and too often those who move things along for public bodies receive more complaints than accolades. Erin Dean and Josh Gruber particularly were of great assistance in addressing this matter.

I believe you are both very familiar with the easements negotiated by BJWSA with the County, Clarendon Farms, and REA Contracting in this area, whereby Clarendon negotiated generally the right to manage and control access from the rail boundary at Middle River to the north southward to the end of its properties along Ihly Road (at that time, to the boundary of REA on the west, and the Second Grays Hill Baptist Church on the east). REA obtained easement rights along Jeter Road on the west side of the rail tracks up to where Clarendon Farms began. The County has easement rights for the rail ROW otherwise beyond these areas. Along Ihly Road, this would include the area from Poppy Hill road north to the Clarendon Easement lying to the east of the railroad tracks and the REA easement. I attach a drawing I have marked up to orient you to this description.

Now that Clarendon owns all of the properties along Ihly Road lying to the east of the railroad tracks, and has agreed to provide the alternative routing for the trail as required under the easement agreement with BJWSA and our understandings with the County, I would like to seek an easement amendment to include the area over which the County has easement rights to the north of Poppy Hill Road up to the Clarendon easement. The trail provisions in the Clarendon easement will



continue to provide for the alternative routing from Poppy Hill out to Highway 21. This would not affect the REA area, which is slightly enlarged to eliminate some gaps. As an aside, Clarendon Farms recently purchased 58.51 acres, being all but 8.3 acres of the REA Contracting property (REA is now known as the Lane Corporation) taking access off Jeter Road, and there is a Right of First Refusal between Clarendon and Lane for that remaining 8.3 acres.

We ask for this so that in the near future we can fence and gate this area to assist with wildlife management and to remove this remote area from use by those who have no business down there, and have been dumping white goods, trash, and other items as well as engaging in suspicious behavior, likely drug related.

I have attached a proposed easement Amendment for your consideration, as well as the survey more clearly identifying the various areas involved along Ihly and Jeter Roads.

I would appreciate your favorably passing this request along to your attorneys and staffs for review, and coordinating with me in my efforts to gain your Council's and Board's approval to modify the easement areas. For convenience, the REA easement is recorded at Book 3025 at Page 1482; the Clarendon Easement is at Book 2936 at Page 82.

The easement area granted to Lane in the Lane Easement Agreement (Book 3025 at Page 1482) is amended by replacing the legal description of the easement area granted to Lane with the legal description on Exhibit B attached hereto and made a part hereof, containing Easement Area B (containing 1.1 acres), Proposed Easement Area A Expanded (containing 0.8 acres), which includes Easement Area A (containing 0.4 acres), as depicted on the plat referenced in Exhibit B.
- 3. The Easement Area granted to Beaufort County in the County Easement Agreement (Book 3027 at Page 2495) is amended by replacing the legal description of the easement area granted to Beaufort County with the legal description on Exhibit C attached hereto and made a part hereof, containing 4.1 acres total, including the area of discrepancy as depicted on the plat referenced in Exhibit C.
- 4. Beaufort County does hereby transfer and convey to Clarendon, its successors and assigns, all of Beaufort County's interests in the easement area described on Exhibit C, and does hereby transfer all of Beaufort County's rights and obligations regarding the easement area as set forth in the County Easement Agreement to Clarendon





**BACKGROUND:** Beaufort County issued a Request for Proposals (RFP) from qualified vendors capable of providing ferry services for Daufuskie Island residents and Beaufort County School District students. The intent of the RFP is to select the most qualified responsive/responsible vendor whose schedule of service, support, and price is in the best interest of Beaufort County and BCSD. The scope of services requires the selected vendor(s) to provide a complete, efficient ferry service, including the necessary labor, supervision, equipment, licenses, and insurance.

An evaluation committee was established consisting of the following members: Gregory McCord, BCSD's Student Services Chief Officer, Morris Campbell, Beaufort County Director of Community Services, and Bud Boyne, Beaufort County Director of Drug and Alcohol. Dave Thomas, Beaufort County Purchasing Director and Sandi Amsler, BCSD's Procurement Coordinator facilitated the process and provided guidance to the committee. On March 19, 2014, Beaufort County received two responses to the RFP from the following vendors: J & W of Greenwood and Haig Point. The evaluation committee reviewed both responses and completed interviews on April 16, 2014 and requested "Best and Final Offers" from the two vendors with a response date of May 1, 2014. After review of the "Best and Final Offers" and consideration of the RFP evaluation criteria scoring, the committee recommended Haig Point to provide ferry services for the BCSD students, Beaufort County Fire, EMS, and staff. J & W of Greenwood is recommended to provide ferry services for Daufuskie Island residents/property owners.

#### JUSTIFICATION:

#### Haig Point

Total annual cost: \$145,000 (see attached "Best and Final Offer")

This vendor offered the best supporting schedule and price for the BCSD students, Beaufort County Fire, EMS, and staff. Ferry services were not offered for the Daufuskie Island residents/property owners. This vendor also offered a thirty (30) minute ride versus a one (1) hour ride provided by the other responsive vendor.

In fiscal year 2014, Beaufort County had a contract with Haig Point for providing ferry service for Beaufort County Fire, EMS and staff with an annual cost of \$20,000.

#### J & W of Greenwood

This vendor provided three options.

1. Total annual cost: \$440,000 (see attached "Best and Final Offer")

Option 1 provides services for Beaufort County and BCSD including a year round early morning and a late afternoon trip. After school activity trips would have a cost of \$220 per hour using a smaller six (6) pack boat or \$375 per hour for a larger boat. The six (6) pack boat will not carry all of Beaufort County's Fire and EMS employees. We require a minimum seven (7) passenger boat.

2. Total annual cost: \$320,400 (see attached "Best and Final Offer")

Option 2 provides ferry service to the BCSD students, Daufuskie Island residents/property owners, Beaufort County Fire, EMS, and staff on a school year schedule. This option does not meet the needs of the Fire/EMS shift schedules.

3. Total annual cost: \$225,600

Option 3 continues the current contract terms and conditions plus ticket sales.

J & W of Greenwood is the only public ferry service vendor offering to provide service for the residents/property owners of Daufuskie Island. J & W of Greenwood provides Monday through Friday round-trip service and two Saturdays per month for \$900 per day. The first and fourth Saturday of the month J & W of Greenwood provides Daufuskie Island departures at 12 noon and HHI departures at 6:00 p.m. (5:00 p.m. during EST daylight savings time). For any times not covered under the contract schedule, Beaufort County pays \$13 for a resident on a space available basis. County officials and employees may ride one way for \$10 each. Limited parking is available for Daufuskie Island full-time residents only. It is their responsibility to secure the parking from Palmetto Breeze. The parking cost is \$30 per month. Additionally, J & W of Greenwood will continue to provide ferry services during emergencies as noted in the contract. J & W of Greenwood is not requesting any increase for this contract term under option 3 above.

As you know, I represent Wick Scurry and the J & W Corporation of Greenwood. Wick has asked me to formally respond to your memo dated April 28, 2014 referenced above. In doing so, I will refer to the formal proposal submitted by the J & W Corporation of Greenwood on March 19, 2014, as well as to the Contract Extension/Renewal currently in effect between J & W and the County (dated June 27, 2013). In addition, reference is made to the 2012-2013 contract dated August 28, 2012. Copies of all are attached for your ease of reference.

J & W's "Best and Final Offer" is as follows:

- a. In response to Paragraph 2 of your memo, J & W reiterates that it will provide the services outlined in its proposal of March 19, 2014 for the School District, the resident/property owners, Beaufort County Fire, EMS, and Staff on the schedule set forth below for a flat fee of \$320,400, payable in monthly payments as set forth in Attachment B to our March 19, 2014 proposal.
- b. In response to Paragraph 3 of your memo, as set forth in our March 19, 2014 proposal, for the flat fee of \$320,400, J & W will provide services for the School District, the resident/property owners, Beaufort County Fire, EMS and Staff on the schedule set forth below:

1. During the regular Beaufort County nine-month school year, beginning on Monday the week school begins and ending on Friday the week school ends, J & W will have a boat leave Daufuskie Island at 6:10 a.m. and arrive Hilton Head at approximately 7:10 a.m. Monday through Friday. During the same time period, J & W will have a boat leave Hilton Head at 4:00 p.m. and return to Daufuskie at approximately 5:00 p.m.

> 2. Beginning on the Monday after Beaufort County schools end and going through the Friday of the week before Beaufort County schools begin in the fall, J & W will move to a "summer schedule" and have a boat leave Daufuskie at 8:15 a.m. for Hilton Head on Mondays, Wednesdays, and Fridays, and on those days during the summer, J & W will have a boat leave Hilton Head for Daufuskie at 4:00 p.m.

> 3. Beginning on the Monday after Beaufort County schools end and going through the Friday of the week before Beaufort County schools begin in the fall, as part of its "summer schedule," J & W will have a boat leave Daufuskie at 12 noon for Hilton Head, on Tuesdays and Thursdays, and on those days during the summer, J & W will have a boat leave Hilton Head for Daufuskie at 4:00 p.m.

> 4. On the first and fourth Saturdays of each month during Daylight Savings Time, J & W will have a boat leave Daufuskie at 12:00 noon and leave from Hilton Head for Daufuskie at 6:00 p.m. During Eastern Standard Time, J & W will have a boat leave Daufuskie at 11 a.m. and leave Hilton Head for Daufuskie at 5:00 p.m.

> 5. Under this schedule for transporting the School District children, the resident/property owners, Beaufort County Fire, EMS and Staff, we remind you that these specific runs from Hilton Head to Daufuskie will be the only Hilton Head to Daufuskie runs that will be open to school children, the resident/property owners, Beaufort County Fire, EMS and Staff. The other boats that J & W will run at various schedules from Hilton Head to Daufuskie will be dedicated to tourism and marina business. However, as with the current contract, J & W will allow residents and property owners of Daufuskie to board any of the "return boats" from Daufuskie to Hilton Head on a "space available" basis.

> 6. Under this proposed schedule, all boats that are to leave Daufuskie and come to Hilton Head, will leave at the designated times or earlier. In other words, should J & W's business needs dictate, J & W will be free (upon two weeks public notice given at Freeport Marina) to schedule the first daily run from Daufuskie to Hilton Head at an earlier time, which will benefit all.

7. Under this proposed contract, it will be acknowledged that the aforementioned scheduled ferry trips are also J & W business ferry trips, with the County/School District/ EMS/ Fire contract payments purchasing the agreed upon times for specifically scheduled runs. However, it is recognized by all parties, that all J & W ferry runs are also part of J & W's on-going business, and as such, any or all ferry runs may be "narrated" by J & W personnel or designated agents, or otherwise be used to enhance J & W's business as long as the narration or other actions do not materially impact the ridership on the boats by any Daufuskie residents, property owners, school district employees, school children, EMS, fire or other County authorized personnel.

c. If the County, the School District, and the Fire/EMS agencies want J & W to run a year round early morning "round trip" and a late afternoon "round trip" to accommodate the EMS/Fire rotational staffing needs, J & W will do so for an additional flat fee of \$120,000 on top of the \$320,400, for a total annual flat fee of \$440,400. That fee would provide year-round guaranteed ferry runs on the following schedule:

1. Monday through Sunday, year round, J & W will have a boat leave Hilton Head (Broad Creek Marina) at 5:00 a.m., to arrive at Daufuskie (Freeport) at approximately 6:00 a.m., then leave Daufuskie Island at 6:10 a.m. and arrive Hilton Head at approximately 7:10 a.m.

2. Monday through Sunday, year round, J & W will have a boat leave Hilton Head at 4:00 p.m. and arrive at Daufuskie at approximately 5:00 p.m., then leave Daufuskie at 5:10 p.m. to arrive at Hilton Head at 6:10 p.m.

3. Under this schedule for transporting the School District children, the resident/property owners, Beaufort County Fire, EMS and Staff, we remind you that these will be the only Hilton Head to Daufuskie runs that will be open to school children, the resident/property owners, Beaufort County Fire, EMS and Staff. The other boats that J & W will run at various schedules from Hilton Head to Daufuskie will be dedicated to tourism and marina business. However, as with the current contract, J & W will allow residents and property owners of Daufuskie to board any of the "return boats" from Daufuskie to Hilton Head on a "space available" basis. - d. As to the information requested on the "pricing sheet" attached to your April 28, 2014 memo, J & W is not in the position to "break out" the costs within the flat fees quoted above for the School District separately from the County. There are inherent costs of vessel operations that simply can't be partitioned out for accounting purposes. J & W does not desire to be considered for a contract that would provide services only for the BCSD, school staff and its children riders.
- e. As to question number 3 on the "pricing sheet," J & W reiterates again, as was stated in my March 19, 2014 letter and J & W's proposal, J & W will agree to enter into a new contract identical in scope and requirements to the existing contract dated June 17, 2013, for the same annual fee. J & W will sign such an agreement for a two year term, with three consecutive one-year options for Beaufort County. The basic contract amount on an annual basis, which is \$225,600 (plus ticket reimbursement for the second and third Saturdays of each month and all Sunday tickets sold), would remain the same.
- f. As to question number 4 on the "pricing sheet," the cost for an emergency trip for Fire/EMS on a "six pack" boat (one captain and room for six passengers), will be \$220 an hour, running from the time the boat leaves Broad Creek until the boat re-docks at Broad Creek, to be billed in minimum 15 minute increments.
- g. As to question number 5 on the "pricing sheet," J & W will only provide evening/extra trips for the BCSD if a base contact is signed including the BCSD as set forth above. If that occurs, then J & W will make a good faith effort to provide a "six pack" boat (with room for up to six children or adult passengers) upon reasonable notice at the cost of \$220 an hour from Broad Creek Marina to Freeport and back. Such a "six pack" run would include a captain (who will be above the age of 21) who will fulfill the requirements of Part III, "Scope of Work" Section 1.3, that requires a responsible adult "in the cabin" to ensure student supervision and safety. There will not be a second crew member assigned to these "six pack" boats.
- h. If the BCSD requests evening/extra trips that will require a larger vessel (a typical "ferry" size vessel), such trips will be billed at an hourly rate of \$375 per hour from leaving Broad Creek until returning to Broad Creek.




