Review for Marine Corps Air Station Beaufort and Marine Corps Recruit Depot Paris

Island Update

The Department of Defense has awarded a \$475 thousand grant to the Lowcountry Council of Governments, in partnership with Beaufort County, the City of Beaufort and the Town of Port Royal was to prepare a Military Installation Resilience Review for Marine Corps Air Station Beaufort, the Marine Corps Recruit Depot Parris Island, and the surrounding communities. It is a new Department of Defense planning grant program, and it is one of the first awarded. This project will be a cooperative, strategic process among Marine Corps Air Station Beaufort, Marine Corps Recruit Depot Parris Island, and the surrounding communities.

The goal is to develop strategies and an implementation plan to protect resources necessary to maintain military installations in relation to natural hazards. Although it may not be possible to contain natural disasters and long-terms conditions such as sea level rise, it is possible to plan and make changes in physical structures and procedures to safely accommodate and prevent damage, and even potential loss of mission. This project is a natural next step after the Sea-Level Rise study, which was a product of the same team five years ago.

Unlike many military facilities, the surrounding communities and organizations provide much of the infrastructure for both MCRD Parris Island and MCAS Beaufort. Infrastructure provided locally includes sewer and water treatment and distribution facilities, as is electrical power, and the roads and bridges that provide access to Parris Island and the Air Station. The surrounding communities also supply a large share of the medical care, residential, social, economic, educational (from pre-school to post-secondary), retail and other services for the military population.

The project which concludes February 2022, will determine what changes and improvements to the area's infrastructure are needed and then how to feasibly implement those recommendations in order to ensure that MCAS Beaufort and MCRD Parris Island are able to continue their operations successfully.

A request for proposals seeking consulting services was issued December 14th, 2020. The proposals are due back on January 20th, 2021. The Technical Committee comprised of local planners and engineers will serve as the scoring committee.

Ginnie Kozak is serving as Military and Government Liaison under contract throughout the length of the project.








Allocations, By Type
