# **MINUTES**

# **Beaufort County Airports Board**

March 21, 2024 | 1:30 pm | Meeting called to order by Chairman Howard Ackerman

## **AGENDA ADOPTION**

Rich Sells made a motion to adopt the March 21, 2024, BCAB meeting agenda. Brian Turrisi seconded the motion. All were in favor and the motion passed.

# **APPROVAL OF MINUTES**

James Starnes made a motion to approve the February 22, 2024, meeting minutes. Anne Esposito seconded the motion. All were in favor and the motion passed.

## **PUBLIC COMMENTS**

## **DIRECTOR'S REPORT**

Jon Rembold recognized members of the audience -- Lisa Kindwall, a local representative from Rep. Nancy Mace's office; Councilman Reitz; Derek Roth, Signature Aviation's new Area General Manager | HXD & SAV; John O'Toole and Kelly Brunson, with the Economic Development Corporation; and Hank Amundson, Beaufort County.

**a.** PROJECT LONE PALMETTO: John O'Toole provided a detailed presentation of the proposed project.

Description: 5,000 sq. ft. of general aviation facilities and 94,000 sq. ft. in hangar space.

Metrics: \$23,700,000 investment, 51 new jobs (Average compensation \$80,250), and \$2.6 million in taxes from facilities and aircraft.

Economic Impact: \$163.6 million (8 years per Clemson University's Regional Economic Analysis Lab) Environmental/Noise Impact: Less than 70 decibels off-site.

There was some board discussion following the presentation.

# **Staff Spotlight:**

<u>Elena Milbrandt</u> - Elena was recognized as an Outstanding Employee at the March 11, 2024, County Council Meeting.

Matt Moore - Matt completed his FAA check ride and is now a new private pilot.

**ARFF Symposium:** Jon Rembold informed the board that Kevin King and Mark Haskett participated in the ARFF Symposium in Punta Gorda, FL. He said that Kevin and Mark will put together a class and share the information with the rest of the team.

**Shamrock 5K Run & Walk:** Rembold mentioned that HXD sponsored the Shamrock 5K Run & Walk in Hilton Head.

**The Eras Gala Chamber Ball:** Rembold said that Board members Leslie Flory and Anne Esposito had the opportunity to go to the Chamber Ball.

**HXD Billboard:** Rembold noted the billboard on Hwy 278 was purchased with grant funds and that there is an electronic billboard on Hwy 170.

**Chamber Leadership 2024 Class Airport Tour:** Rembold informed that students from the leadership class continue to visit the airport.

**Terminal Updates:** Rembold mentioned that he sent a stakeholder update to the airlines, the FAA, and the State. He commented on the temporary wall built next to the Delta station and stated that things are changing rapidly. He said the fence is getting a banner with the RBC Heritage, FedEx, and Airport logos. He informed both canopies have been removed. Rembold stated that the weather has been great, and much progress has been made.

# **AIRPORTS' BUSINESS UPDATE:**

# **Taxiway F Rehabilitation:**

Rembold informed that everything has been submitted to the FAA, and the final greenlight is pending. He mentioned that a pre-construction meeting was held, and a game plan has been set. He said the construction will happen at night over a period of 28 days.

# **Tower Upgrade:**

Rembold said that some equipment is a bit slow to come. He mentioned the upgrade will provide updated electronics and communications equipment. He stated that the equipment is going to be updated to touch screens and the latest technology.

# St. James Baptist Church (SJBC):

Rembold informed that after a push from the FAA, the SJBC project is moving along and is being considered in the State's budget. He said preliminary drawings are being reviewed.

# **RBC Heritage Volunteers:**

Rembold reminded that the Airport is going to have a major sponsorship at the event. He said opportunities to volunteer at the tournament will be available.

### **Evaluation Score:**

Rembold informed that responses to the RFQ for Airport Planning Services are back in, and the evaluation team reviewed all the packages and went through the scores. He said the Tally Sheet shows Talbert, Bright and Ellington as the winner.














# CONCEPTUAL SITE PLAN










