The meeting was called to order by Commissioner Bright @ 18:10.

Budget - Fiscal Year 2015

This year's budget proposal has a \$110,879 total increase from last year's budget. That includes:

- \$33,702 in personnel costs with just standard promotions and longevity.
- Using the exact same plan and not making any changes, the medical was increased by \$52,000 with the biggest factor being the Affordable Healthcare taxes and fees. We are looking at other options so this is the worst case scenario. We will have a better idea once we get closer to the renewal date.
 - \$1,000 increase for property and casualty insurance.
- \$7,000 increase for internet & cable. (Hargray honored our prices from charter for one year and that year was up half way through our current budget cycle.)

The county has estimated our mil value to be \$66,949 with a millage rate of 60.18 and debt millage rate of 5.74.

Total Operations Proposed Budget of \$4,779,051.

Projected to collect \$4,029,051 by taxation.

\$375,000 contract money from City of Beaufort and Town of Port Royal

We are looking at a shortfall of \$375,000 shortfall which would come from fund balance if needed.

Proposed Capital Improvements purchases:

- 10 Air packs \$65,000
- 40 Masks \$13,400
- 20 sets of turnouts and boots \$50,000
- 2 Thermal imaging cameras (replacing 2 bought in 2001) \$24,000

\$152,400 total requesting from fund balance.

2015 Pumper

We have not gone to bid yet but we are getting the specs ready. For now we are using a rough estimate of \$600,000. We paid off two loans this year totaling an annual payment of \$38,000.

We would be looking at requesting \$120,000 from the general fund, \$100,000 from debt service and \$80,000 from impact fees for a down payment. We will finance the rest which would be roughly \$300,000 with a \$50,000 estimated annual payment. Doing this would not cause a raise in taxes. (All of these are just estimates, we do not have any quotes/bids at this time.)

Commissioner Harris motioned to allow Chief Rountree to present the budget to County Council as drafted.

Commissioner Lanier seconded.

Vote was unanimous. Motion approved.
