Entered into an Intergovernmental Agreement with the Town of Hilton Head Island for an exchange of the Otter Hole Transfer Station site and 1.03 acres at the old library site

Entered into a Memorandum of Agreement with the Town of Bluffton and Rowkris Development I, LLC, as it relates to the donation of property to the US Postal Service to locate a new US Post Office Facility, at no charge, if necessary. The donation is contingent provided the Town of Bluffton and Beaufort County commit to the funding and timing of certain infrastructure improvements currently included in the redevelopment plan entitled "Amendment to the Tax Increment Financing Plan for the Redevelopment of the Bluffton Surface Transportation System for the East-West Highway Corridor District".

Approved closing The Sands boat ramp from 1:00 a.m. on July 8, 2000 to 1:00 a.m. on July 9, 2000 in order for the Gullah Festival Committee to hold their "Jammin at the Sands" Festival.

Awarded a contract to NewVision Systems Corporation of Stanford, Connecticut, in the amount of \$327,616 for a new official records imaging system.

The 43 corrected parcels are: R600 032 000 018, 132, 133, 153-172, 217-236 0000. (vi and vii) The wrong parcel was designated Olde Towne Village [CU-600 PUD].
