Council Action Summary March 2000

March 13, 2000

Proclaimed March 2000 as Disabilities Awareness Month in Beaufort County.

Presented a plaque to Captain Doug Gertis and Mr. David Tolman in recognition of unselfish support in savings a citizens' life. On March 8, 2000 at approximately 1:06 p.m., a citizen jumped from the Woods Memorial Bridge. Mr. David Tolman, without concern for his own safety, jumped into the Beaufort River and rescued the citizen. Captain Doug Gertis, a private boater who was at the downtown marina, used his personal boat to assist in the rescue effort. The Beaufort City Police Department, Beaufort Fire Department, Beaufort County Emergency Medical Services and the US Coast Guard all responded to provide assistance.

The funding source is the \$10 motorized vehicle fee.

Adopted a resolution designating April 2000 as Fair Housing Month.

Authorized the creation of a staff attorney position.

Approved on third and final reading an amendment to the Zoning and Development Standards, Appendix H, creating the Lady's Island Fishing Village Overlay District.

Members appointed from the five planning areas shall reside within the unincorporated portions of those areas, while members appointed at-large may reside anywhere within the County, including municipalities.

Approved on second reading proposed text changes to the Road Facilities Impact Fee Ordinance.

Approved on third and final reading an ordinance to amend the FY 1999-2000 budget for Emergency Operations Center activations during Hurricanes Dennis, Floyd and Irene in the amount of \$785,243.

Extend the County's workers' compensation coverage, under its policy with the SC Workers' Compensation Trust, to Disabilities and Special Needs clients, Detention Center inmate workers, volunteer EMT's and volunteer reserve deputies. This resolution confirms County Council's intent to provide said coverage effective January 1, 2000.

Approved on first reading a request for zoning change on Port Royal Island, District 100, Map 31, Parcel 20, from Community Regional to Commercial Suburban.

Approved on first reading a request for zoning change on St. Helena Island, District 300, Parcel 31A, from Rural and Rural Residential.

Awarded a term contract to The Palmetto Conservation Foundation, a non-profit organization, in the amount of \$30,000, not to exceed \$40,000, to provide consulting to develop a criteria and ranking system for the Beaufort County Land Preservation Program, application procedures and forms, development of model conservation easements, educational materials, conduct public education workshops and educational assistance to the Land Preservation Board. The funding source is the interest accrued on the two mills levied for land preservation.

Voted to recommend to the Governor the appointment of Mr. Pat O'Neal to serve as a member on the B/J Water and Sewer Authority, replacing Mr. John Ballantyne when his term expires July 2000.
