Approved on first reading, by title only, pursuant to S.C. Code Ann. §4-10-300, et seq. (Supp. 2003) and subject to approval by referendum, an ordinance to impose a one-percent sales and use tax within Beaufort County to fund multiple capital projects in the amount of \$117,203,500 for not more than five years.

Approved on third and final reading the proposed FY 2004-2005 School District budget in the amount of \$131,196,672 to be made up of \$98,646,682 from tax collections, \$28,500,181 from state revenues, \$600,000 from federal revenues, \$300,000 from local revenues, and \$3,149,809 to decrease the School District previous year fund balance.
