Adopted a resolution agreeing to participate in the SC Retirement Systems Tax-Deferred Payroll Deductions for Installment Service Purchase.

Awarded a change order for \$242,370 to Steadfast Marine for remedial work at the Broad Creek Boat Ramp due to unforeseen soil conditions.

Awarded a contract for Technical College of the Lowcountry South Campus Phase 1 Site Development to J. R. Wilson Construction Co. in the amount of \$1,798,740.40, with the understanding that the contract will be immediately reduced by deductive Change Order to \$1,502,926.35.

Awarded Contract #30 to REA Contractors, LLC, for the construction and paving of Grandee Oaks Drive, Lakeview Court and intersection improvements for Broad River Boulevard/Joe Frazier Road in the amount of \$890,535.50.

Awarded an initial contract to Carolina Cleaning in the annual amount of \$314,830.20 for northern facilities, \$195,206.52 for southern facilities, and to Father and Sun Cleaning, St. Helena Island for northern facilities in the amount of \$45,024. Total contract award of \$555,060.72.

Authorized the County Administrator to finalize the negotiation with Oaks Construction for a three-year lease with two, one-year options and, further, to see if the lessor would extend the option terms, but not extend the lease beyond ten years.

Adopted a resolution expressing its interest in establishing a Lowcountry Regional HOME Consortium made up of the local governments in Beaufort, Colleton, Hampton and Jasper Counties and requests that Lowcountry Council of Governments prepare such an application to HUD. The County further understands that local matching funds may be required and that a final commitment must not be made until the application package is submitted in June 2005.

Authorized the Burton Fire District to use \$185,040 in fire impact fees for the purchase of a new fire truck for the Habersham Fire Station and the construction work at the Grays Hill Fire Station.

Authorized the Sheldon Fire District to expend \$350,000 in capital improvement funds for the purchase of a new tanker at a cost of \$150,000 and a new pumper at a cost of \$200,000. The debt service payment will occur in FY 2005-2006 and will require an approximate .5 millage increase.

Awarded a contract to REA Contracting, LLC, in the amount of \$635,000 to design and build the Simmonsville Road Convenience (Drop-off) Center.

Awarded a contract to Beaufort Construction, Inc., in the amount of \$1,659,400 for the Hilton Head Island Airport Hangar Design/Build Construction project.

Awarded a one-year, fixed price contract to ADS, Inc., Charleston, SC, for ten sizes of HDPE pipe and fittings in the amount of \$170,963.10, with up to two annual renewals to be offered at the discretion of the County.

Awarded a contract to Cunningham Associates, Inc., Charlotte, NC, in the amount of \$34,231.85 for playground equipment and installation for the Burton Wells Facility.

Awarded a one-year contract, with up to four annual renewals to be awarded at the County's discretion, to ABL Management, Inc. Baton Rouge, LA, in the amount of \$298,763 to provide complete food service to the Beaufort County Detention Center.

Approved on third and final reading text amendments to the Beaufort County Template Ordinance: Section III (B)(5), term (provides at-large appointment of Library Board with Council Member consent) and Section III(E)(2) (provides reasonable cause exception for removal from board).

Adopted a resolution fully supporting and endorsing the establishment of a Corridor Commerce Park and authorizing the staff of the County to cooperate with the Partnership to move forward with such efforts including, but not limited to, the following: (1) Identifying prospective sites for such a Corridor Commerce Park. (2) Preparing a report indicating the minimum criteria a Corridor Commerce Park must meet to be certified by the State of South Carolina; (3) Identifying prospective sources of funding for the design and development of a Corridor Commerce Park; and (4) Participating in Community Development Block Grant and other grant planning activity being undertaken by Beaufort County and the State of South Carolina concerning Economic Development in the Corridor area.
