Appointed Ms. Anita Nelson, representing St. Helena Island, to serve as a member of the Historic Preservation Review Board.

Appointed Mr. Malcolm Goodridge, representing Council District 10, to serve as a member of the Rural and Critical Lands Board.

### October 24, 2005

Approved on first reading, by title only, an amendment to the Admissions Fee Ordinance to clarify County Council's legislative intent that Council intended to impose a user fee on actual usage on an amount actually paid for admissions, not the privilege.

Awarded a contract to Johnson Controls in the amount of \$802,088 to design and construct the Detention Center HVAC replacement. The funding source is \$788,132 in Capital Improvement Program funds plus an additional \$13.956 from the FY 2002-2003 contingency funds.

Adopted the 2006 Employee Benefits Package, in conjunction with the County's Benefits Consulting Firm, The Mercer Company, as follows: Health Care Provider-UniCare, Dental Provider-United Provider-Spectera. Concordia. Vision Basic Life/Accidental Death/Dismemberment/Long-Term Disability - Standard, Long-Term Disability-Standard, Flexible Spending-UniCare, COBRA Administration-UniCare, and Employee Assistance-Horizon Health.

Approved the contract renewal between Beaufort County and the Trust for Public Land to include a 21/2% increase or \$6,216 annually year over year.

Awarded a contract to Malphrus Construction Co., Inc. in the amount of \$22,640,560.10 for construction of the Bluffton Parkway Phases III A, B, C and IV

Adopted a joint resolution that the County of Beaufort and the Beaufort County Board of Education, as partners, agree to obtain a consultant and/or legal services to advise and represent the county and the school district in their pursuit to amend or change the present Educational Finance Act. Furthermore, Beaufort County and the Board of Education agree to equally fund this effort in an amount not to exceed two hundred and fifty thousand dollars (\$125,000.00 each). In addition, the County and the Board of Education will meet with local state delegation and State Assembly representatives at the statehouse in Columbia to express the need to modify the Act and to pursue other public education funding possibilities.

Adopted a resolution authorizing an amendment to an Intergovernmental Agreement by and between the County of Beaufort, South Carolina and the Town of Bluffton, South Carolina so to provide for an additional contribution from the Town of Bluffton in the amount of \$750,000.00 to be expended towards the costs of improvements to Phase III and IV of the Bluffton Parkway.
