Awarded a contract to Brickman Group in the amount of \$53,702 to construct a landscape buffer for Traditions at Old Carolina funded from the Tree Mitigation Fund.

Adopted a resolution approving the Tanger Hilton Head Outlet Center I – Development Agreement Right-of-Way Deed wherein each reference in the Development Agreement to the size of the right-of-way parcel being "2.3 acres" shall be replaced with "2.526 acres" and all provisions of the Development Agreement shall remain in full force and effect as if "2.526 acres" had been referenced as of the date and time the Development Agreement was adopted by ordinance by the Beaufort County Council.

Adopted a resolution authorizing the County Administrator to prepare and submit a Community Development Block Grant (CDBG) Community Infrastructure Application in the amount of \$500,000 for the St. Helena Penn Center Library Project and to commit funds in the amount of 10% of the grant request to meet the matching commitment of the Community Development Block Grant Program.

Awarded a contract to Creative Structures in the amount of \$1,669,415.43 to construct a new Aircraft Rescue and Fire Fighting Station at the Hilton Head Island Airport. The funding source is an FAA Grant (95%), State Grant (2.5% pending), and local County match (2.5%) is \$41,735.38. Funding for this project will come from the Airport Enterprise Fund (AEF). If there are insufficient funds in the AEF, an advance will be made from the General Fund to be repaid once airport funding becomes available.

Awarded a contract to Cleland Site Prep, Inc. in the amount of \$355,335.85 for Runway Safety Area Drainage Improvements at the Hilton Head Island Airport. Funding for this project will come from an FAA Grant (95%), State Grant (2.5% pending), and local County match (2.5%) is \$8,883.38. Funding for this project will come from the Airport Enterprise Fund (AEF). If there are insufficient funds in the AEF, an advance will be made from the General Fund to be repaid once airport funding becomes available.

Held a public hearing and approved on third and final reading text amendments to the Beaufort County Zoning and Development Standards Ordinance (ZDSO), Appendix D--Community Preservation (CP) Areas (adds Interim Standards for newly-formed Coosaw Island CP District). adopt a resolution approve the County and Fire District millage rates adjusted for the 2009 tax year millage rollback (excludes School District).
