PUBLIC COMMENT

The Chairman recognized Ms. Shirley Johnston, a resident of Okatie, who believes she has a responsibility to protect the rich saltwater eco-system that is her backyard. The proposed trash transfer station on Chechessee Road is much too close to the ecologically-sensitive marsh and adjoining areas to be a viable location for a trash transfer station or for any purpose that could result in damage to this eco-system.

Mr. Peter Ferrier, a resident of Okatie, distributed copies of a September 5, 2013 Editorial entitled, "Chechessee wrong site for central waste facility," that appeared in the *Island Packet*. The article mentions the Rural and Critical Lands Preservation Program acquisition of more than 600 acres for more than \$8 million along S.C. 170 from the Broad River near the potential waste facility that includes almost 100 acres of Manigault Neck, directly adjacent the site the county is considering for a central waste transfer station. Why spend all of this money to preserve land and then build a trash transfer station on this common boundary?

Mr. Jimmy Baker, a Chechessee community property owner thanked Council for its patience and professionalism listening to the residents for the last several months during Council meetings as well as answering constituent telephone calls and emails and attending meetings. We all believe that Chechessee Road is not the appropriate location for a trash transfer station.

Mr. Bill Evans, Chairman of the Board of Education, stated the Board of Education (Board) supports the ordinance to amend Beaufort County Ordinance No. 2013/26 to reflect a reduction in the millage rate from 100.55 to 97.45 to achieve the same appropriated revenue amount of \$121,297,587. The Board is taking this step, because as the School District continues to grow there is going to be a point where the Board will come back to Council to ask for something extra. He hopes that door is always open.

COUNTY ADMINISTRATOR'S REPORT

The County Channel / Broadcast Update

Mr. Gary Kubic, County Administrator, said The County Channel has all programs, events and meetings available to watch online, on-demand at www.bcgov.net. The County Channel recently entered into a partnership with the Town of Hilton Head Island to broadcast its Town Council meetings live on the air. The County Channel will air the Town's meetings every other Tuesday at 4:00 p.m. Meetings will also be available for replay and on the web.

The County Channel recently aired a special live episode of Coastline from Beaufort County's Emergency Operations Center. The topic was Hurricane Preparedness. Host Rick Forschner spoke with Emergency Management Director Todd Ferguson, Animal Services Director Tallulah Trice, and Jeff Althoff from Lowcountry Insurance. Topics included: how to get your home ready for a hurricane; what to do with your pets; and how to proceed after a storm. Coastline's latest interview was with County Council Chairman Paul Sommerville. Coastline's next guest

will be Bluffton Town Police Chief Joey Reynolds. Residents will be able to call in all month long, and leave a message with their question.

Coastal Kingdom has been picked up by South Carolina ETV. The nature series will air statewide on ETV's South Carolina Channel, (Hargray Channel 109) on Tuesdays at 8:00 p.m. The show will be seen around the state. The LowCountry Institute, who partners with the County, on the production of the show, provided the funds to have the entire series Closed Captioned (for the hearing-impaired), and brought to within FCC guidelines. ETV will air all 11 episodes, and continue to broadcast new ones as we complete them.

Presentation / Fort Fremont Visitor Center

Mrs. Linnea Ganquist, County Planning Department Surgmer Intern, narrated a video highlighting the design of the Interpretive Center for Fort Fremont Passive Park. The Center supports an initiative of Council in 2004 when it purchased Fort Fremont and nearly 15 acres of land through the Beaufort County Rural and Critical Lands Program. The property was purchased for use as a passive park. Fort Fremont, located on St. Helena Island at Lands End, was built from 1898 to 1900 in response to the Spanish-American War to provide protection for Port Royal Sound. It was an active U.S. Army installation until 1911 and was formally closed in 1912. It was sold by the Federal government to private interests in 1921.

REMARKS FROM THE CHAIRMAN

The Chairman has been asked two questions. The first question, "Why does the millage apply to personal property as well a real property especially when millage is rolled up rather than back as in years' past"? The answer, "Because it is required under state statute. State statute says that you cannot have two separate millage. Whatever millage applies to real property (home and land) has to apply to personal property (automobile, boat and airplane)."

The second question, 'If Council is going to reduce the School District millage, why not reduce it on the County as well. If the logic applies to the School District, why does it not apply to the County?" The answer, "It does. The School District millage is impacted by some factors that the County millage is not impacted. There are two tax increment financing districts, New River and Port Royal I, rolling off this year which complicates this process. All entities that are not within those TIFs are essentially rolling forward to almost the same amount of money they received last year. Those entities, within those TIFs rolling off, will have some cushion built in because when a TIF rolls off, it does not create more additional ad valorem taxes. What it does is re-routed the tax money allocated to those TIFs back to the original taxing entities that were

paying into those TIFs to start with. The School District makes an assumption, different from the County, about their collection rate and the percentage of their receivables that will be appealed."

It is a complex issue. The millage Council is asked to rollback is \$3.1 million. If you applied the same formula to affected millage the County, in fairness, it would reduce the County millage by 0.8. We did not ask that the County millage be reduced by 0.8. You could make an argument that we should have; we did not. It is a very small amount, but if someone wants to make that point feel free, because you are absolutely correct.

PUBLIC COMMENT

The Chairman recognized Ms. Ann Ubelis, a resident of Lady's Island, who thanked the Board of Education for having the courage to come forward and lowering the millage rate. She asked Council to show the same courage and reduce the millage rate.

Mr. Jim Bequette, a resident of Lady's Island, stated the School District came forward and lowered its millage rate. Where is the County's reduction?

Mrs. Leigh Woods, a resident of Beaufort, stated that Beaufort County has a great opportunity to change the way things are done. We live in a special part of the world, but we have to keep taxes reasonable.

Ms. Diane Moreno, a resident of Bluffton, stated the County tax increase will affect all of the residents and inadvertently affect all of our business community. Please reconsider the tax increase.

Mrs. Jane Kenny, a resident of Bluffton, remarked now is not the time to raise taxes. These are hard times.

Mr. Gary Wilson, a resident of Burton stated higher taxes will be a burden on just about everybody.

Mr. Steve Curless, a resident of Beaufort, stated the HUD headcount of our homeless population was 700 as of January 2013. He discourages Council from raising taxes at this time.



ORDINANCE NO. 2013 /

AN ORDINANCE TO AMEND BEAUFORT COUNTY ORDINANCE NO. 2013/26 SO AS TO REFLECT A REDUCTION IN MILLAGE RATE.

WHEREAS, on June 24, 2013, Beaufort County Council adopted Ordinance No. 2013/26 establishing the fiscal year 2013 - 2014 budget for the Beaufort County School District; and

WHEREAS, final reassessment numbers were provided to the Beaufort County School District on August 23, 2013; and

WHEREAS, this reassessment information indicated an increase in the millage value from what was originally provided to the Beaufort County School District on March 25, 2013; and

WHEREAS, Ordinance 2013/26 established a millage rate at 100.55 appropriating \$114,868,815 in local tax revenue.

NOW, THEREFORE, BE IT ORDAINED by Beaufort County Council that Beaufort County Ordinance No. 2013/26 is hereby amended to reflect a millage rate reduction from 100.55 to 97.45 to achieve the same appropriated revenue amount of \$121,297,587.
