Thank you, Herbert.

This is our first official ground breaking for a sales-tax-funded highway improvement project north of the broad river, it is a significant step forward in bringing our county transportation system up to speed, so to speak.

This \$40 million project is funded entirely with sales tax dollars as approved by voters in November of 2006, it includes widening sc 802 from U.S. 21 to Ribaut Road and the construction of a new bridge parallel to the McTeer Bridge.

The wisdom of our citizens in approving this project was made very clear following the mishap in 2007 when a barge ran into the McTeer Bridge. Fortunately, D-O-T worked quickly to resolve the issue.

Currently, the existing McTeer Bridge is designed for 16 to 18,000 vehicles each day, it is over capacity with an average of 22,000 vehicles each day, the new parallel bridge will increase capacity to safely and efficiently accommodate the 35,000 plus vehicle trips per day anticipated in the years ahead.

The roadway and intersection improvements in connection with this project will also take the strain off SC 802 through Lady's Island and the Town of Port Royal, I would like to thank our municipal partners for their involvement and contribution to our transportation improvement plans for Beaufort County.

When the people of Beaufort County approved the referendum to fund this project and others, they put their trust in us., we are proud to stand here today ready to do their bidding.
