BEAUFORT COUNTY TRANSPORTATION COMMITTEE MINUTES OF MEETING ON March 15, 2017

The regular meeting of the Beaufort County Transportation Committee (BCTC) was held on March 15, 2017 in the Executive Conference Room of the Beaufort County Administrative Complex located at 100 Ribaut Road, Beaufort, South Carolina.

- 1. <u>Call to Order & Members Roll Call</u>. Meeting was called to order at approximately 4:00 p.m. by Chairman Gordon and an attendance roll call was taken. A quorum was achieved for this meeting.
- 2. Public Comment. No public comment given.

3. Approval of Minutes

Motion: a motion was made and seconded to approve the minutes from the January 18, 2017 meeting. Motion passed unanimously.

4. Old Business

- A. <u>Update on County Roadway Pavement Condition Survey</u>. Mr. McFee provided an update on the status of the County Road Pavement Condition Survey. The contractor, F&ME Consultants, has one more week of data collection locally and then will go to Daufuskie Island. It will then take 4 to 6 weeks to get data into units and then develop worksheets. Portland Cement will present information on pavement full depth reclamation. F&ME will also discuss pavement preservation. A workshop was scheduled for Wednesday, April 19th in the Engineering Department Conference Room.
- B. <u>Status of SCDOT and BCTC Projects</u>. Mr. McFee reviewed BCTC projects. Engineering design for Contract 50 County dirt road paving is 80% completed. The wetland permit reviews have taken longer to be completed by OCRM. This paving project should be ready for bid in May or early June. Contract 50 includes 7 dirt roads: Coker Lane, Butler Farm Road, Albertha Fields Circle, Shiney Road, Almond Drive, Mary Smalls Road and Devonwood Drive. Contract 50 will be the last traditional dirt road paving contract to be advertised for bid. From this point forward per the BCTC's Transportation Plan, the BCTC will receive petitions from property owners requesting for dirt road improvements/paving. Property owners will be responsible for providing the necessary right of way documents. The 2016 SCDOT Resurfacing is well underway by Lane Construction Committee. Substantial completion is during June 2017. Under new business a budget adjustment request was submitted by the County Engineering Department.

Mr. Mulligan updated the CTC on the status of SCDOT projects. SCDOT Just had a pre-construction meeting for several road resurfacing work areas. Total project mileage is 6 miles. Several sections on SC 170 will be resurfaced/paved. SC 170 from the new turn lane at US 21 to the Albergotti Creek Bridge and then from Roseida Road to Shanklin Road will have new asphalt applied. SC 170 from the newly widened section at McGarvey's Corner to the new Burger King site will be resurfaced. On US 21, 1.7 miles will be resurfaced from Washington Farm Road to Gardens Corner. Resurfacing on US 278 from Skull Creek to Pinckney Island and then to Shelter Cove is also included.

C. <u>Budget Adjustment for 2016 SCDOT Roadway Resurfacing Contract</u>. The County Engineering Department has submitted a request for a budget adjustment totaling \$240,000 for the 2016 SCDOT Roadway Resurfacing Contract with Lane Construction Company. Mr. McFee presented this request included in the minutes as Attachment #1.

Motion: A motion was made by Mr. Forrest and seconded by Mr. England for the BCTC to approve a budget increase to the 2016 SCDOT Resurfacing Project for \$240,000 with funding from the remaining unspent FY 2016 25% mandate funds of \$90,000 and \$150,000 from the uncommitted C Fund balance. The motion passed unanimously.

The project budget will now be \$6,400,000.

5. New Business

- A. <u>Selection of the 2017 SCDOT Roadway Resurfacing/Improvement Projects</u>. Mr. McFee presented the recommended 2017 SCDOT Roadway projects which include:
- 1. Resurfacing Palmetto Bay Road, HHI 4 –lane roadway, approximately 1.0 miles from Sea Pine Circle to Charles E Fraser Bridge. Estimated Cost \$1.7 million
- 2. Improvements to the Bridges Approaches for:

US 21 Chowan Creek Bridge

SC 170 Broad River Bridge

SC 170 Chechessee River Bridge

Estimated Cost - \$240,000

The projects listed above were reviewed in depth at the BCTC workshop held on February 28, 2017.

Funding for the 2017 projects would come from the 2017 nonrecurring C Fund distribution of \$1,295,000, the 2017 25% mandate from recurring C Fund deposits estimated to be \$580,000 and the remainder from uncommitted project funds.

County Engineering will not administer these projects. A Request for Programming will be sent to the C Program Administration. The estimates include the 7% for PE&I and 5% contingency for each project. The resurfacing on Palmetto Bay Road would be coordinated with the Town of Hilton Head.

Motion: A motion was made by Mr. Runko and seconded by Mr. Forrest for the BCTC to approve the 2017 SCDOT Roadway projects submitted by staff. Funding would be from the 2017 Nonrecurring C Fund Distribution, 25% mandate and any uncommitted project funds as needed. The motion passed unanimously.

- B. <u>BCTC Liability Insurance</u>. Chairman Gordon has discussed with Mr. Herb Cooper, SCDOT C Program Administrator, the BCTC member's accountability for approval use of C Funds on projects. This was discussed at the February 28th workshop. At the September 2016 CTC meeting, Chairman Gordon presented to the committee a letter from Mr. Cooper. This letter included an opinion from the SC Attorney General on a project funded by the Marlboro County CTC and whether it was an appropriate use of C Funds on an approved committee project. Mr. Runko and Mr. England volunteered to work on obtaining insurance options and costs for coverage for the BCTC. They will coordinate with Mr. McFee.
- 6. Public Comment. No public comment given.
- 7. <u>Meeting Adjourned</u>. The May 17, 2017 meeting will be held at 4:00 p.m., in the Executive Conference Room, County Administration Building, Robert Smalls Complex, Beaufort, SC.

Budget Adjustment for the BCTC 2016 SCDOT Resurfacing Project

BACKGROUND. On April 25, 2016, the Beaufort County Council appropriated \$6,160,000 for the County wide SCDOT resurfacing project to Lane Contracting, Inc. Funding for the 2016 SCDOT road resurfacing is taken from the following sources:

2016 Non-Recurring C Fund Revenue

\$5,667,823

2016 25% Mandate from Recurring C Fund Revenue

\$ 492,177

\$6,160,000

The 2016 SCDOT Resurfacing is a unit price contract and includes approximately 28 miles of roadway at various locations throughout the County.

This budget adjustment is necessary for the significant amount of full depth patching and leveling required on most of the 28 miles of roadway due to years of deferred maintenance. The total adjustment needed for the project budget has been calculated at ±\$240,000.

The funding for this budget increase would be a \$90,000 transfer of unspent funds from the remaining 2016 25% mandate and \$150,000 from the BCTC's total uncommitted funds with a present uncommitted present balance of \$2,574,461. The new budget for the 2016 SCDOT Resurfacing would be \$6,400,000 and is funded from the following sources:

Therefore it is recommended by the County Engineering Department that the BCTC approve an overall total budget increase of \$240,000 funded from the remaining unspent \$90,000 2016 25% mandate and \$150,000 from the uncommitted C funds.

RECOMMENDATION. That the BCTC approve a budget increase of approximately 3.9% to the 2016 SCDOT Resurfacing Project of \$240,000 with funding from the remaining unspent 2016 25% mandate funds of \$90,000 and \$150,000 from the uncommitted project C fund balance presently at \$2,574,461.
