1. **Call to Order & Members Roll Call.** The meeting was called to order at approximately 5:33 p.m. by Chairman Moss.
2. **Pledge of Allegiance.** Chairman Moss led the Pledge of Allegiance.
3. **Opening Remarks.** Chairman Dean Moss gave opening remarks and presented a supplemental agenda.
4. **Approval of Agenda.**  
**Motion:** It was moved by Untron Solomon, seconded by Frank Turano to approve the agenda.

6. **Project Discussion.** A motion was presented by Frank Turano of \$500m, 1% sales tax for ten years. Untron Solomon suggested the same percentage and term but a cap of \$700m. The motion was amended by Frank Turano and seconded by Rob McFee. Motion passed with an 11:1 vote with Craig Forrest voting no. Craig Forrest suggested four different buckets: System Preservation, Safety/ITS, New Facilities/capacities, Multi modal transportation.
