Thank you for the opportunity to respond to your request to prioritize the County Sales and Use Tax project list.

The priority list has been divided into three categories, immediate priority, midterm priority and long term priority.

Immediate priority: Jenkins Island Access (\$7,400,000), Pinckney Island Access (\$2,000,000), Safe routes to schools (\$4,640,000)* and EMS facility (\$6,000,000).

Midterm priority: US21 ITS Bridge (\$500,000), 278 traffic safety improvements (\$5,600,000), detention center (\$1,000,000) and dark fiber/infrastructure upgrade (\$1,500,000).

<u>Long-term priority</u>: Bridge Widening/Replacement (\$5,000,000), 278 improvements Jenkins to Squire Pope (\$4,500,000) and Waddell Improvements (\$750,000 sales tax : State 250,000).
