## June 2015 Local Admissions Fees Fund Financial Narrative and Analysis

The local admissions revenues are about \$12,000 lower in June of this fiscal year (2015) compared to June of last fiscal year (2014).

There were operating expenses relating to personnel, purchased services, and supplies that total about \$51,000.

The Local Admissions Fund transferred \$1.5 million to the County's Debt Service Fund for the Bluffton Parkway, which is the entire budgeted transfer amount for fiscal year 2015

This leaves an ending fund balance of \$1.83 million in the local admissions fund.
