APPROVAL OF AGENDA:

Vice Chair McElynn made a motion to approve the agenda. Peter Kristian seconded. The vote to approve the motion was unanimous.

ADOPTION OF MINUTES – JULY 18, 2025:

Senator Davis made a motion to adopt the minutes of the July 18 meeting. Peter Kristian seconded. The vote to approve the motion was unanimous.

EXECUTIVE SESSION:

Peter Kristian made a motion to go into Executive Session pursuant to S.C. Code Section 30-4-70 (A) (2): discussion of negotiations incident to proposed contractual arrangements for the following proposed Green Space applications:

- Fee Simple Application, Buckfield Tracts, Yemassee
- Update and Discussion on Buckwalter PUD Tracts, Bluffton

Senator Davis seconded. The vote to approve the motion was unanimous.

The Committee was in Executive Session from 10:02 AM to 11:25 AM.

MATTERS ARISING OUT OF EXECTIVE SESSION:

Fee Simple Application: Buckfield Tracts, Yemassee

Tim Evans made a motion to recommend approval of the application to the Natural Resources Committee for Phase 1 of the Buckfield Tracts while continuing with the necessary due diligence, capping the grant at \$7 million, which is the amount requested in the grant application. The motion was seconded by Peter Kristian. The vote to approve the motion was unanimous.

Update and Discussion: Buckwalter PUD Tracts, Bluffton

Senator Davis said the Town of Bluffton and an entity known as Inland Bluffton, LLC have entered into a nonbinding letter of intent in regard to a 55-acre tract known as 5C which is adjacent to parcels 5A and 5B which the Green Space Committee recommended approval at their last meeting. Senator Davis said the Town of Bluffton intends to submit a Green Space application for this property. Senator Davis made a motion that when the Town of Bluffton submits the Green Space application for Parcel 5C, which will likely be next week, staff be authorized to receive it and process it outside of the usual quarterly deadlines so that the Green Space Advisory Committee can consider the application at their September 12 meeting. Vice Chair McElynn seconded. The vote to approve the motion was unanimous.

OTHER BUSINESS:

There was no other business discussed.

ADJOURNMENT:

The meeting was adjourned at 11:29 AM.
