- 1. CALL TO ORDER: Chairman Murphy called the meeting to order at 3:00 pm
  - **a. Approval of Agenda:** Chairman Murphy requested a motion to approve the agenda. Ms. Floyd motioned; Ms. Bray seconded. All approved
  - **b.** Approval of Minutes (11/08/2018): Chairman Murphy requested a motion to approve the minutes. Ms. Voge motioned; Ms. Floyd seconded. All approved
- 2. INTRODUCTIONS: All introduced themselves. Chairman Murphy welcomed Councilman Passiment who described his involvement as a 'Road Warrior'. Councilman Passiment indicated he was happy to be in attendance and congratulated the great work by KBCB
- 3. PUBLIC COMMENT: There was no public comment
- 4. REPORTS FROM BOARD REGARDING MEETINGS WITH COUNTY COUNCIL: Members noted general contact with Council members or attempts to contact. Mr. Campbell recognized the attendance of Councilman Dawson. Campbell noted conversation with Councilman Sommerville and stated Sommerville is 100% supportive of KBCB efforts. Mr. Boehme indicated that new Councilman Lawson gives unconditional support and is optimistic of goals moving forward
- 5. UNFINIFSHED BUSINESS:
  - a. Updates from Sub-Committees: Ms. Fruh described contact with Experience Green and the Master Recyclers class moving forward. Currently looking for funding sources. Ms. Voge noted opportunity for OLLI class potential
- 6. **NEW BUSINESS**:
  - a. Presentation Friends of Gardens Corner: Mr. Criscitiello presented a PowerPoint and

provided handouts concerning the future of Gardens Corner. A zoning map was available for review and potential funding sources were discussed. This is a vision for 50 years from now. Pedestrian traffic encouraged. Mr. Wilhelm will follow-up with Director Larson in an effort to secure in-house planning assistance. Tree Reforestation Fund mentioned as a potential resource. A long-term maintenance plan was mentioned by Chairman Murphy

- **b. 2019 Palmetto Pride Grants Litter Prevention and KSCB:** Ms. Carter reported that 2019 grants have been awarded. KSCB awarded to KBCB for \$8,750 and Litter Prevention awarded to Beaufort County for \$15,000
- **7. PUBLIC COMMENT:** There was no public comment
- 8. BOARD REQUESTS: There were no Board requests. Mr. Wilhelm updated members on feedback from Palmetto Pride to support and expand the Beaufort County Fall Clean-up due to partnerships with Jasper and Hampton Counties in the Spring. Ashley Jenkins thanked Ms. Fruh (Outside Foundation) for her support of CRA. Artrell Horne shared end-of-year litter totals. Councilman Dawson thanked KBCB and Mr. Criscitiello for his presentation. He also expressed his appreciation for the Public Works Litter Team's efforts. Ms. Voge thanked County Codes staff for resolution to a recent open dump situation
