- 1. CALL TO ORDER: Chairman Campbell called the meeting to order at 2:01 pm
 - **a. Approval of Agenda:** Chairman Campbell requested a motion to approve the agenda. Ms. Vogue reminded that Sub-Committee discussion be delayed until 2021. Ms. Floyd motioned to approve. Ms. Murphy seconded. All approved
 - **b.** Approval of Minutes (10/8/2020): Chairman Campbell requested a motion to approve the minutes. Ms. Floyd motioned; Ms. Murphy seconded. All approved
- 2. INTRODUCTIONS: Due to Webex format, absentees were noted from the virtual participant list
- **3. REPORTS FROM BOARD REGARDING MEETINGS WITH COUNTY COUNCIL:** Chairman Campbell reminded Board that per COVID-19, no meetings or contact is expected. KBCB Board, as a group, are in good standing. Chairman Campbell indicated he had a meeting with Interim County Administrator Eric Greenway. Pam Floyd reminded all that Councilman York Glover attended the Veronica Miller ceremony in October

4. UNFINISHED BUSINESS:

- a. Review of Sub-Committees: Chairman Campbell will review these in 2021 as noted in 1.a.
- **b.** Beautification Project Updates: Dale on hold until spring. Friends of Gardens Corner Chairman Campbell updated that the corner is progressing with watering (the Greenery) and repairs have been completed from auto incident
 - c. Veronica Miller Memorial (future award nominations): Speakers were great and the event was beautiful. Good turnout. Michael Murphy, Laura Lee Rose and Friends of Hunting Island did the work. Ms. Murphy organized. Mr. Miller (husband) was pleased. Post event lunch with Sarah Lyles (Palmetto Pride). Chairman Campbell indicated that he discussed possible partnership with the State Prison in Ridgeland for litter removal on Highway 17 in the future
 - **d. Design of KBCB logo Palmetto Pride KSCB Grant:** The Nancy Rhett artwork was not approved by Palmetto Pride. Caroline Dolbey has been working with Alpha Graphics to develop a logo per the 2020 Keep South Carolina Beautiful grant stipend. All Board members had an opportunity to

- review the design prior to the meeting. All have agreed to move the design forward. It will be presented to Public Facilities Committee by Ms. Carter on December 21, 2020. Ms. Carter advised that a 60-day extension has been granted by Palmetto Pride to complete the 2020 grant
- e. Beaufort County Convenience Center Update: Ms. Carter updated the Board on the upcoming implementation of a decal system for the Convenience Centers. Very labor intensive program initially and 35,000 applicants expected. 20,000 have been processed, to date. The County may have a 'soft opening' January 2, 2021. Gate and Pritchardville Centers will close 12/31/2020

5. NEW BUSINESS:

- **a. Keep Jasper County Beautiful Affiliate 2020:** Ms. Carter updated all that Jasper County has a new affiliate per press release by Palmetto Pride. Chairman Campbell will reach out to their contact, Lyn Boyles
- **b.** Adopt-A-Highway Update newsletter: Ms. Dolbey is working on the 2020 newsletter. Waiting on a few more feature articles. 2020 a stellar year for volunteers. Chairman Campbell suggested inviting guests (such as Elizabeth Penn Sanders) to future Board meetings. Ms. Vogue inquired on SC DOT mowing cycles in Beaufort County
- **c.** Canceled: KAB Conference Washington DC (February 16-18): Information only. Chairman Campbell encouraged participation for future conferences
- d. Recycling Coordinator: Ms. Carter updated that Ashley Jenkins has left her position with Beaufort County Solid Waste and Recycling for a new opportunity with the SC Department of Commerce. Ms. Jenkins will be missed. Her position has been posted and interviews are scheduled for next week. Hopefully the vacancy will be filled quickly
- e. 2021 Palmetto Pride Grants applications: Ms. Carter reported that both the 2021 Litter Grant and 2021 Keep South Carolina Beautiful grant applications have been submitted. Ms. Carter reminded the Board that the 2021 KSCB award will be delayed pending the completion of the logo project for 2020
- **f.** Fall Clean-up Beaufort County (SWR, PW, P&R): Ms. Carter reported that 60 county staff participated on November 18th. Organization headed by Artrell Horne. All Council Districts were included in the litter removal project
- 7. PUBLIC COMMENT: There was no Public Comment (per e-mail or phone opportunities)
- **8. BOARD REQUESTS:** Chairman Campbell asked for any Board comments. Ms. Carter reminded all to see the Beaufort County Facebook feature for Jean Fruh (October 5). Request from Chairman Campbell for stationery after logo approved. Ms. Gualdoni suggested a beautification effort for the two Convenience Centers after the infrastructure removed. Chairman Campbell reminded all that we can continue to support Adopt-A-Highway efforts to remove roadside litter
- **9. ADJOURNMENT:** The meeting adjourned at 2:54 pm. The next scheduled meeting is February 11, 2021 at the Port Royal Sound Foundation, Okatie, SC

KBCB Subcommittee Draft List August 2018

- Covered Load Enforcement Liaison to all County law enforcement entities to encourage covered load enforcement on pickup trucks, landscape and homeowner trailers and registered waste haulers.
- Property Management/HOA Liaison Contact Property Management companies and community HOAs and encourage them to promote 100% recycling within their respective domains and management areas.
- Curbside Recycling Taskforce Work with County Council and Public Works to bring this long-delayed vision to fruition.
- Alternate Recycling/Reuse Sources Seek out alternate sources for RRR and compile a data base for homeowners. Promote through social media and other sources. Examples: Lowes-Plastic landscape pots. UPS Store and home-based shippers - clean packing material.
- Education Promote Reduce and Reuse before Recycle. Reduction of contamination of recyclables at transfer stations. Rotation speaker for Rotary and other civic groups. Encourage the recycling of the most profitable /marketable items.
- Legislative Liaison Contact legislature to help encourage drawing industries in to area to make the recycling stream more profitable using tax incentives and give-backs.
- Magistrate Liaison Encourage litter fines and community service.
- Sherriff Department Laison Encourage Litter Control Officers to be assigned more duties that could help prevent/reduce littering.
- Event Recycling Encourage/promote greater participation across all venues.

- Partnerships Contact like-minded groups active in the County and link through social media to increase the dessimation of our message. Port Royal Sound Foundation, Clemson Extension, Friends of Gardens Corner, Open Land Trust, Friends of Spanish Moss Trail, Friends of Hunting Island, The Outdoor Foundation and on and on.........Please help me add to this list!
- Grants/Projects Work with staff to develop grant requests and compile an ongoing list of projects that the respective grants can help be applied to.
- Community Awards There are phantom volunteers out there doing small
 productive projects on their own who are going unrewarded. Let's find them
 and support and acknowledge them.
- SCDOT Liaison We have an open and friendly relationship with current SCDOT staff. Let's make it easy to communicate to each other.
- ADAH-River Sweep-Beach Sweep-Kayak Cleanup Emissary Bring a message of thanks to groups as they start or complete a pick-up event.
- Planning Department Liaison Connect with Planning Department staff on beautification project that might concern them.
