1. **CALL TO ORDER:** Chairman Campbell called the meeting to order at 1:02 pm.
  - a. **Approval of Agenda:** Chairman Campbell requested a motion to approve the agenda. Ms. Voge motioned to approve. Ms. Floyd seconded. All approved.
  - b. **Approval of Minutes (8/11/2022):** Chairman Campbell requested a motion to approve the minutes. Mr. Althoff motioned to approve. Ms. Floyd seconded. All approved.
2. **INTRODUCTIONS:** All attendees present are familiar. Matt Riccobene with the Beaufort County Sheriff's Office was introduced.
3. **SUB-COMMITTEE UPDATES:**
  - a. **EDUCATION AND LITTER ENFORCEMENT** – Mr. Boehme provided an update on recent meetings he has been involved with to develop and implement an education program for Beaufort County schools. He has contacted Tracy Shrader of Waste Management for support as well as Dr. Rodriguez. Ms. Floyd and Ms. McFee commented that the curriculum must be approved at the State as well as any textbooks. Mr. Boehme is aware of the approved SC DHEC program. Ms. Voge commented that 'with education comes willingness'. Mr. Boehme stated he has had a conversation with Sheriff Tanner per enforcement. We are in a time period of lessening the potential for 'sparks'. Mr. Boehme stated he has the support of the Island Packet for coverage. Ms. Voge volunteered her help with any item that might overlap with Legislation.
  - b. **LEGISLATIVE** – There is Board interest in continuing to research a "Scenic Highway" proclamation for the highway to Hunting Island.
  - c. **BEAUTIFICATION** – Ms. Laura Lee Rose (Clemson Extension) will be happy to assist the Board with plantings post-retirement. The circle at Joe Frazier is still under discussion for wildflowers. Chairman Campbell has contacted County and SCDOT staff per input to the future Highway 278 plantings. en Space initiatives and the status of the Southern Beautification Board.
