1. **CALL TO ORDER:** Mr. Wilhelm called the meeting to order at 3:00 pm
2. **INTRODUCTIONS:** All attendees introduced themselves. Board members gave a brief background
3. **PUBLIC COMMENT:** There was no public comment
4. **ELECTION:** Mr. Inglese explained the nomination process. Each nominee was asked if they were willing to serve. There was one nomination for each of the 3 positions to be filled. Clarification was made that the Chairman and Vice Chairman are not related and would not be absent at the same time. The Secretary position will be supported by Public Works administrative staff. All positions were voted unanimously: Chairman: Michael Murphy; Vice Chairman: Carol Murphy; Secretary: Joan Gualdoni. Upon completion, the Chairman led the remainder of the meeting. Ms. Murphy thanked Mr. Inglese for his work with the KBCB Board/"fellow do-gooders"
5. **NEW BUSINESS:**
 - a. **FY18 PALMETTO PRIDE KSCB GRANT UPDATE:** Ms. Carter gave an update on the KSCB grant for FY18. There was open discussion on Secure the Load tarps and promotional items. All agreed to the tarps/decals listed in the grant application; ordering recycled content koozies for promotion
 - b. **REPORTS FROM BOARD REGARDING MEETINGS WITH COUNCIL MEMBERS:** Ms. Carter reminded each member to stay engaged with their assigned Council representative in order to share information from the Board
 - c. **SC DOT – CONTACT:** Ms. Carter noted Elizabeth Penn- Sanders is the new engineer. Ms. Carter encouraged interaction for any future beautification projects that may impact State property
 - d. **BCSO; WASTE HAULERS – LITTER:** There was open discussion per contacting County waste haulers to minimize litter and BCSO per enforcement. Public Works will support mechanism determined to meet with group(s). Vice Chairman Murphy will head this initiative as a sub-committee to be formed

- e. **COUNTY EVENTS UPDATE:** There will be a litter clean-up day 5/23/18 for all Beaufort County employees that wish to participate
- f. **PUBLIC WORKS – SW&R UPDATE:**
 - 1. **Litter Team:** Mr. Horne will head up a maritime litter control presence during the upcoming Beaufort Water Festival in July; a new quarterly program has been initiated with the Marine Corps to assist with roadside litter removal; the Town of Bluffton will have a clean-up day 5/19/18. Please use BC Connect to report littering or open dumping (smart phone app)
 - 2. **Litter Index:** Ms. Dolbey reminded members of the upcoming litter index survey for Palmetto Pride/KAB. All areas were assigned. Forms to be returned at the next meeting
