1.5 Approval of January 24, 2019 Minutes

2. Presentation

- 2.1 Presentation to retiring Board Member: Mr. Henry Lawton, Sr.
 - Mr. Henry Lawton served on the LCOG Board for over 40 years and is the longest living member. He was presented with a plaque and gift that commemorates his time on the board.

2.2 Main Street South Carolina Program-Ms. Jenny Boulware

There are 23 local programs statewide. There are 271 municipalities in our state. Not every area has a main street. Main Street has a 4-pt approach. It is DOPE: (1)

Design—restoring physical value, (2) Organization—restoring the civic approach, (3) Promotion—restoring social value, and (4) Economic Development—restoring the economic development value. In 2018, there were 41 improvement projects and 60 businesses opened. This created 229 jobs.

 - Answer from Ms. Knight: "I think they're unincorporated areas because that's basically what we were looking at for the Hampton County projects. We were looking at areas outside the town limits."
 - Ouestion from Mr. Nat Shaffer: "They are demo-ing what?
 - Answer from Ms. Knight: "Those are vacant residential properties that are attracting nuisances. That's what we're looking at".
 - Copies of the Community & Economic Development report were distributed in the packets.

3.3 Director's Report - Ms. Sabrena Graham

The South Carolina COG-MPO 2019 Conference was held February 4-5 in Beaufort. The conference, with its overall goal of promoting a multi-modal transportation system across the state, focused on topics related to intermodal planning and asset management via local projects, best practices, and issues pertinent to the area. Approximately 70 people attended.

LCOG has been asked to submit an application on behalf of Jasper Council on Aging and Beaufort Senior Services. Hampton has decided to apply on their own behalf this year seeking funds for a vehicle.
