#### **CALL TO ORDER**

Tom Ertter called the meeting to order at 3:10 PM. The pledge of allegiance was said by all present.

#### PUBLIC COMMENT

No request to speak during public comment.

#### **NEW BUSINESS**

- A. YMCA: The YMCA made a proposal to use two of PALS pools to host swim lessons for their summer-campers 2 days a week, for eight weeks, for a total fee of \$1,000.00. The YMCA charges for summer camp and also gets a grant to teach swim lessons to the migrant children. After much discussion about admission fees for in-county and out-of-county resident fees and the cost of the lifeguards for the program. It was decided that a counter offer with admission fees of \$1 for in-county residents and \$2 for out-of-county residents be charged per swim class, and that the YMCA would assume all costs for lifeguards; this will be revisited every year for evaluation of fees and costs. A motion was made and the vote was unanimous.
- **B. New Organizational Chart:** Shannon Loper proposed a new organizational chart with additional positions and responsibilities. The Athletic Managers are now in charge of one sport in particular for accountability purposes which seem to be a more streamlined process. Mr. Kubic approved that the lifeguards be changed to Water Safety Instructors. He wanted to have the Boards approval before considering the rest of the proposed organization chart. The Board stressed the importance of moving forward with the new marketing position as soon as possible. A motion was made and the vote was unanimous.
- C. County Employee Wellness Program: Shannon Loper proposed free membership for County employees as a perk of employment and to establish a wellness program. A motion was made to pursue this with Josh Gruber and the vote was unanimous.

There were no further concerns that needed to be addressed at this time. The next Board meeting will be held on February 2, at 2:30 PM at the Buckwalter Recreational Center in Bluffton, SC. The meeting was adjourned at 4:10 PM.
