#### FRIENDS OF BEAUFORT

Mr. Miller reported a recommendation from Trust for Public Land (TPL) and Rural & Critical Land Program (RCLP) to form a citizen group. This five-member group, tentative referred to as Friends of Beaufort will be comprised of three (3) members of RCLP Board and two (2) members from PALS Board (a representative from Northern and Southern Beaufort County). This committee would report their fundraising findings to RCPL Board and PALS Board. Mr. Miller recommends selection of PALS Board representation for Friends of Beaufort at next PALS Board meeting.

#### FOOTBALL AGE GROUPS

Mr. Miller reported Northern Beaufort County PALS has not yet made a recommendation for any changes to football age groups. PALS staff has reported number in terms of football participation. The report indicates there are twenty-five (25) 12 year olds in the Northern Beaufort County, which covers three (3) districts. Mr. Miller expressed his desire to keep football age grouping at its current setting. Mr. Hill expressed his concern for safety in age groups where there is a large disparity in weigh differences, namely the 8-10 year old group. Mr. Brown recommends PALS Board Program Committee meet to further discuss numbers and make recommendation to Board at next meeting. Mr. Penale suggested acting on this issue as soon as possible with football registration beginning in July. Board agreed that Program Committee will meet May 10, 2007 at 2:30 p.m. at Burton Wells Recreation Center. Stacie will contact all Committee members, Board members and media.
