CALL TO ORDER

The meeting was called to order by Bruce Yeager.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was recited.

INTRODUCTIONS

Introductions were completed.

APPROVAL OF AGENDA

Bruce Yeager asked for a motion to approve the agenda. A motion was made to approve the agenda. The motion was seconded, and the agenda was approved.

PRESENTATION: Friends of Burton Wells:

Bonnie Gordon thanked everyone for the invitation to come and speak with the board. The mission of the Friends of Burton Wells Regional Park organization is to support Burton Wells, the over 300 acres of property north of the Broad. They would like to be a community liaison between Parks and Rec and the community. In their opinion, there is so much room to improve programs. When the community held a meeting, they became aware of things that the community feels can be done at the Burton Wells location. The Friends of Burton Wells would like to be that buffer between the two entities. The Friends of Burton Wells see how much growth potential there is with the Master Plan in its original form. The Friends of Burton Wells would like to work hand in hand growing our programs and help with donation of funds to programs and centers. Bruce Yeager commented that there was a similar organization, People for Parks, on Hilton Head that spearheaded fundraising that went into Crossings Park. Bruce Yeager stated that Friends of Burton Wells need to work complimentary with Parks and Recreation. He also stated that this is just an advisory board and capital project decisions are made by the County Council and Elected Officials. Eric Brown explained that while it would be great to host the different tournaments our focus is providing recreation for the people of Beaufort County with our in-house sports. Eric Brown also stated that the travel community is for a small percentage of participants. We are expecting to host the Baseball Tournaments in the future. Bonnie Gordon stated that the travel portion of what they are discussing is small, what they are interested in is the Buckwalter facility and the impact it has on the Bluffton community. The people in Beaufort would like to have a facility like that as well. They would like to have something comparable. Bruce Yeager explained that the priority of the board is to provide accessibility to recreation for the people of Beaufort County, and that we probably needed better PR as to what is available at the Burton Wells facility. Eric Brown said he would meet with the group to come up with a way for the Friends of Burton Wells and Parks and Recreation to work together to make recreation better in the community.

PUBLIC COMMENT

Joe Mack, a Beaufort County citizen, came before the board with suggestions and concerns about land. Bruce Yeager stated that he did appreciate his comments, but the PAR Board deals with properties that the county already owns. Acquiring more land is a county decision, not a PAR decision.

Bruce Yeager stated that we did not have a quorum at the last board meeting to approve the January 9th meeting. He asked for a motion to be made to approve the minutes. A motion was made. The motion was seconded, and the minutes were approved.

FEE WAIVER / REDUCTION REQUESTS

Scheper Tennis Academy

Janice Johnson spoke on behalf of Scheper Tennis Academy. Larry Scheper has taught tennis to many kids in Beaufort Janice Johnson explained that she has worked with Larry Scheper Tennis Academy since 2009. Last year a tournament was held for one day and the number of participants was larger than expected and they had to scale down the tournament to accommodate the turnout. There were fees associated with the tournament to reserve the courts. This year's tournament will be on the 14th and 15th of June. It is a USTA sanctioned event. Janice Johnson asked if since Scheper Tennis is 501C3, the fees can be waived. Bruce Yeager asked if the kids participating in the tournament are paying a fee. Janice Johnson stated that they were. But the fees were sucked up by the court reservation fees. Scheper Tennis is requesting all 6 courts for 2 days. Phil Kiser asked if this event would be different than the pickleball tournament that was held at the Burton Wells pickleball courts last year. Bruce Yeager stated that it was. The money raised from that event was given to Family Promise in the amount of \$12,687.00 and over 1,000 pounds of food was donated to Second Helpings. Bruce Yeager also stated that Beaufort Tennis had come to us in the past also looking for a fee waiver for a USTA tournament, that request was denied. Bruce Yeager mentioned that a 2-day tournament with 6 courts would cost a total of \$1,080.00. If we have the availability, we could approve a one-time fee reduction of 50%. In the hopes that this will help with the growth of the tournament in the future. Bruce Yeager also asked if the insurance for the event was going to be carried by Scheper Tennis, Larry Scheper stated that it was, Alan Arseneau made a motion for a one-time fee reduction for the 2-day event. The motion was seconded, and the motion was passed. Bruce Yeager asked that they return and give the board a report on the tournament.

Beaufort Water Festival

Sailey Johnson, sports coordinator for the Beaufort Water Festival, stated that last year they did not pay a fee to hold the pickleball tournament and would like to know if it can be waived again. Bruce Yeager stated that he did not recall issuing a waiver for the event last year. Sally Johnson stated that in the past they have not been charged to use the facility since they are advertising Parks and Recreation. Bruce Yeager asked if they were a 501C3. Sally Johnson stated that she did not know but believed that they were. Bruce Yeager asked how many teams there were in the tournament last year and the number of courts used. Sally Johnson replied that there were 20 – 30 teams and all the courts were used. Bruce Yeager also asked about trash clean-up as well as port-o-lets for that day as the Burton Wells facility is closed on Saturday. He also asked if they were taking care of the insurance for the event. Sally Johnson replied that they are handling all of that. Bruce Yeager noted that this was the first time a request like this by the Beaufort Water Festival has been made before the board, but he is aware that things have been approved, circumventing the board by staff that are no longer with Beaufort County and that the Beaufort Water festival is a philanthropic organization. He asked for a motion to be made. Buffy Camputaro made a motion to grant the fee waiver for this tournament while leaving 1 court open. Phil Kiser seconded the motion and the motion was passed. Bruce Yeager also asked that they return to give the Board a recap of the tournament.

Bruce Yeager noted the difference in the check ins between Burton Wells Recreation center and the Buckwalter check ins. He stated that it might be since Burton Wells was rural compared to Buckwalter. Heather Clint commented that might be the case with Burton Wells but did not explain the Charles Lind Brown Center, since it was downtown. Eric Brown commented that we also needed to look at the number of people in Bluffton with around 80,000 residents compared to Burton Wells with 20,000 residents. Heather Clint also mentioned the other Beaufort County Departments that utilize our facilities. Human Resources held a blood drive at Burton Wells Recreation Center on March 18th. County Council held a meeting on March 24th at the Buckwalter Recreation Center. The library hosted their annual meeting on April 22nd at the Burton Wells Recreation Center, showcasing the newly installed Book Box. The Beaufort County annual Earth Day Clean Up luncheon was held at the Buckwalter Recreation Center on the 24th of April. 51 bags of trash were collected from 170 by the PAR staff. County staff collected 9000 pounds of trash along 40 miles of roadway. There was a total of 200 county employes and 500 external volunteers in total.

Bruce Yeager stated that the board would like to have a meeting about the special events fees and the fee schedules. Bruce Yeager asked Heather to reach out to the board when the new fees are decided upon. Phil Kiser asked why there are 2 separate departments, Passive Parks and Parks and Recreation. Audra Antonacci-Ogden stated that they are different departments. Passive Parks, such as Widgeon Point as well as other areas throughout the county. They were purchased through Rural and Critical. They provide no programing where Parks and Recreation provide athletics and programing.
