PLEDGE OF ALLEGIANCE: Chairman Allen Patterson led the Pledge of Allegiance.

REVIEW OF MINUTES: Chairman Allen Patterson asked if there were any changes to the November 7, 2019, meeting minutes. Dr. Caroline Fermin made a motion to accept the minutes as written, and Mr. Jan Malinowski seconded the motion. There was unanimous support for the motion.

IMPLEMENTATION ACTION MATRIX – REPORT OF STANDING COMMITTEES:

This Committee will receive monthly updates from the three (3) standing committees.

A. CIVIC ENGAGEMENT / PUBLIC OUTREACH

There is a need for additional communication with the goal of improved, two-way information exchange utilizing County and City outlets as well as additional websites, Facebook, local newsletters, and newspapers. An active feedback loop involving community members is crucial. We will continue to identify/contact stakeholders utilizing a central data location and those with a vested interest distributing a single, concise message each time. There was no voiced disagreement with the need for a unified voice.

B. TRANSPORTATION

Currently, there are nine (9) local projects, plus the Ribaut Road intersection issue, pending. Rob McFee, Beaufort County Division Director of Construction, Engineering and Facilities, has agreed to assist with FAQ's and status updates.

C. GROWTH MANAGEMENT

There are three (3) areas of growth management currently in progress: septic system/density guidelines, dirt fill limitations, and sea level rise overlay district. Modification of the growth boundary and the monitoring of growth trends is also under consideration and will be part of the updated Comprehensive Plan.

FORMALIZATION OF THE LADY'S ISLAND COMMUITY PRESERVATION COMMITTEE:

The Committee meets at the Lady's Island Airport, 10:00 a.m. the 3rd Monday each month, and is considered a voice for the Lady's Island Community, concerned citizens, residents, and business owners, all working in conjunction with Beaufort County and the City of Beaufort. Committee members are nominated by an existing member.

The Committee, as an advisory group, provides an opportunity for citizens/applicants to have a sense of community viewpoint and/or staff opinion regarding potential issues which are eventually brought before the County or City. The Committee experience also helps to clarify the next steps in the local governmental process.

Lady's Island includes Cane Island, Cat Island, Coosaw Island, Distant Island, Gibbs Island, Goat Island, Judge Island, Lost Island, Marsh Island, and other small islands bounded by Chowan Creek, and the Woods Memorial and McTeer Bridges.
