CALL TO ORDER

Chairman Mike Mathews called the meeting to order at 3:01 p.m.

REVIEW OF AGENDA

Chairman Mathews asked if there were any changes to the Agenda and there were none.

REVIEW OF MINUTES

Chairman Mathews asked if there were any changes to the Minutes from the March 9, 2017 Board meeting and there was one; Mr. Bob Bender was not at the Retreat. With this revision, Mr. Walls made a motion and Vice-Chairman Baker seconded the motion to accept the Minutes with revisions from the March 9, 2017 Board meeting. **The motion was carried unanimously to accept the minutes with revisions from the March 9, 2017, Board meeting** (FOR: Mathews, Baker, Bender, Hill, Mack, Riley, Sullivan, Walls).

GENERAL DISCUSSION

Financial Update

Chairman Mike Mathews stated that there were no major changes to the financial report since the last Board meeting.

Passive Park Update

Mr. Tony Criscitiello stated that Crystal Lake is finished and the tenants should be moving in during the month of June. The future phase of Crystal Lake will be a boardwalk around the entire lake. Fort Fremont will be out for bid next week to build the Interpretive Center and pavilion. Fort Fremont should cost around \$839,000.00. Beaufort County staff was still in the process of obtaining permits from the Town of Bluffton for Okatie Preserve. Mr. Criscitiello attended the Natural Resources Committee on Monday and presented Ms. Lisa Lord and Mr. Ken Drigger's report about the future of the R&C Program and the issue of a stewardship position for passive parks.

TPL Economic Study

Ms. Lisa Lord stated that she held a meeting with stakeholders and the core team and was ready to run the analysis for this study. After that she will generate a report to give back to stakeholders and the core team for review. The final report should be out in the fall.

Future Bond Referendum

Based on the Retreat discussion, Chairman Mike Mathews stated that the Board should prepare the referendum language by the end of the year so that County Council can review it at their retreat in February. The language of the referendum should be the same, but the Board needs to discuss the amount of the bond and how the money will be used. The Board will discuss this further at the next Board meeting.
