Old Business:

New Building - We received a memo from Oceana Design today. We are waiting on Earthquake bore testing. We are two weeks out from getting building permits.

Air Pack Cylinders - They are now in service.

New Business:

Budget - We have two more readings before approval of the budget. Final reading is the 24th.

Bond - The bond for the station is being bided out now. They already have people lined up but they have to advertise it. It is part of the process.

Training - We had Narcan training this week. Narcan is a drug we give for people who have an overdose. We will be keeping these on our trucks. It is a program sponsored by DHEC. It was three different classes about 3 hours per class.

Truck Repairs - I have two big repairs being done before the end of the year. The foam system on the squad trucks being replaces, and 4 tires on the two engine and tankers on the other side (Station 41).

Treasurer's Report - Total drawn to date \$1,408,269, balance left to draw is \$0, with \$171,162 left in our budget with \$290,513 Cash on Hand fund balance. Two weeks left in the year. We have an average of \$85,000 per week. We have an expense on average of \$24,000 per week. **MOTION** to approve Treasurer's Report made by George Williams. **SECOND** by Robert Smalls. **TREASURER'S REPORT APPROVED UNANIMOUSLY**.
