Old Business:

Grants - SFD is still waiting to hear on approval for the FEMA Grant, and the Firehouse Subs Grant was not approved.

Building Construction - John Crouch (the architect) could not be here this evening due to his wife being ill. SFD had to hire someone to replace the Palm Tree and Neal will pay them directly. Board Members were given a Construction Completion Schedule provided by Neal Construction LLC. Phase 2 should be completed by the end of November. There is a need for addition concrete to be poured at the end of the old pad in front of the road. An extra 3 yards of concrete will be needed. Neal Construction has not yet provided a quote, but the Board Members approximate that the cost should not exceed no more than \$2,000.00. MOTION made by George Williams to approve the cost of the additional concrete not to exceed \$2,000.00. SECOND by Robert Smalls. MOTION APPROVED UNANIMOUSLY.

Bay Doors at Station 41 - The Bay Door repairs at Lobeco have been completed.

New Business:

County Ordinance - SFD's budget has a been approved and a copy of new County Budget Ordinance has been provided to the Board Members.

Treasurer's Report - SFD has drawn \$200,000 to date with \$1,453,328 left to draw and \$133,100 left in Debt Service. SFD is on average is spending \$31,996 per week and has \$31,768 per week available. Current checkbook balance is \$412,091. There is approximately \$435,855 in the Cash on Hand Fund balance. This figure may change after the audit. After the Board Members review, **MOTION** made by George Williams to approve the Treasurer's Report. **SECOND** by Greggory Gilbert. **MOTION APPROVED**.
