DISCUSSION

Old Business:

Parking Lot: Chief is still waiting on word from the County. The County did however come out and scrap the whole parking lot and driveway area and did a good job. Chief is not sure if the County will work the driveway and parking area into their budget at this point.

Audit - The CPA is still working on our Audit for last Fiscal Year. All information as been submitted.

Apparatus Maintenance - Overall maintenance has come down. Working on different issues with the insurance with the County taking over our maintenance on vehicles. Once that is worked out and our contract ends with Palmetto Fire, the County will be doing SFD's repairs.

New Business:

New Squad - The new squad is here. Equipment is being installed on it if you would like to take a look at it after the meeting. \$184,677 was used out of the Cash on Hand fund, leaving \$210,000 in the cash on hand fund in SFD's Checking.

Comment - Sheri Phillips - Inquired about accidents on the curve right by the station on Paige Point Road. Chief stated none recently and that the County just cut back all the trees. Sheri suggested maybe a speed bump to slow people down on the curve. Dale will reach out to his contact to see if there is something that can be done to slow traffic down in that area.

Treasurer's Report - Board members received a copy of the Treasurer Report. Total Budget this year is \$1,972,242. SFD has drawn \$700,000 to date with \$1,272,242, left to draw. SFD is on average is spending \$34,000 per week and have \$39,000 funds available per week. Current checkbook balance is \$304,397. There is currently \$210,634 cash on hand funds available. **NO MOTION WAS MADE TO APPROVE THE TREASURER'S REPORT IN THE MEETING.**
