- Call to Order: Chairman Dietz called the meeting to order at 10:00 am
- Minutes: The Mr. Potts motioned, Mr. Norris seconded and the Board approved the October 2009 minutes.
- Monthly Reports
  - Mr. Minor explained that actual disposal is down overall while recycling remains steady at approximately 600 tons per month.
  - o Commercial disposal tonnage down; could be reflective of economy or material going to facility besides Hickory Hill Landfill
  - City of Beaufort tonnage up to 54 tons, Town of Bluffton at 30 Tons, Sun City at 70 tons reflecting the value of curbside systems to increase tonnage. With Sun City curbside system in place, recycling has not decreased at Bluffton sites.
  - o Town of Hilton Heads recycling curbside tonnage now at 29 tons.
  - o SP Paper's new contract is yielding increased revenue while not costing anything for hauling/.
  - o Mr. Minor reviewed the value of compactors is saving hauling costs

#### • Unfinished Business

- o Lady's Island Closing
  - This center has continued closing weekends since 10/17 while closure is under consideration.
- New Shanklin Convenience Center at 80 Shanklin Road
  - This center is ready to open awaiting decision on Lady's Island closure. The attendants from LI were to be transferred to the new Shanklin that will require 2 attendants on duty.
  - Attendants working this center will need additional training to manage the new compactors and flat system.
- o Daufuskie Island Convenience Center
  - Design contract was awarded. Mr. Bellamy noted that the contractor has taken the pla to DRT and we anticipate approval by the end of the year.
- Transfer Station Report
  - RFP for "fatal flaw" analysis of potential sites for a Transfer Station had six firms respond. A panel reviewed the proposals and ranked the proposals. The top four firms have been interviewed. The committee including Mr. Dietz, will reconvene on November 23<sup>rd</sup> to complete evaluation and selection of top candidate and begin contract negotiation process.

- o 2Good2Waste
  - We have received initial approval of initial site development for this on line material exchange. This will come before the Public Services committee November 30<sup>th</sup>.
- Dept of Energy Block Grant
  - Receipt of this \$636k grant is available and approved. It includes compactors for Simmonsville, vehicles and position to start county office recycling, and various lighting retrofit projects. Billie Lindsay constructed the grant with support of the Green Team.
  - Mr. Dietz suggested that this grant be publicized.
- o 2010 Calendar
  - Mr. Potts motioned, Mr. Uehling seconded and the board approved the 2010 calendar as presented with the meetings on the 4<sup>th</sup> Thursday of the month except for Thanksgiving (3<sup>rd</sup>) and December (none).

#### • New Business

- Tour of Hickory Hill Landfill and MRF
  - Immediately following the meeting, the SW&R Board, County Council members and staff were traveling to Hickory Hill for tour and presentation by Waste Management on how materials are processed at the Landfill and the MRF.

- o Scrap Metal and White Goods RFP Process
