## • Special Presentation

- Ms Tamer Middleton was congratulated for being named SC DHEC Attendant of the Year for Beaufort County. Ms Middleton is the 2<sup>nd</sup> most senior attendant, hired 10 years ago and an exceptional employee.
- o Mr. Leroy Brown, retiring attendant was thanks for his years of service.
- Both attendant received plaques and the appreciation of the board.

### Monthly Reports

- o Mr. Minor reviewed the monthly reports.
- o Trend is now that the county is 50/50 on curbside vs. DOC usage
- o The budget is looking very good this year with less than 50% expended at 8 months.
- o Traffic at St. Helena is at 22,000 noting the additional 8-10,000 residents from Lady's Island.
- o Curbside recycling, non existent 2 years ago, currently at 219 tons p/month
- Haig Point on Daufuskie Island is now recycling and delivered 1.28 tons to the MRF
- o Recycling proceeds are at \$271, 122 with \$200k actual revenue.

### • Litter Officers' Reports

- Litter officers are continuing to deal with illegal dumping and litter issues.
- o ZERO Tolerance weekend is April 16-18. The officers will attend meetings in preparation for this event.
