- 1. Call to Order: Chairman Duryea, called the meeting to order at 2:00 pm.
 - A. Agenda: Ms. Corley motioned, Ms. Scott seconded, all approved the agenda.
 - B. Minutes: Ms. Scott motioned, Ms. Corley seconded, all approved the March 23, 2015 minutes.
- 2. Introductions: All present were introduced.
- 3. Public Comment: There was no public comment.
- 4. Reports:

A. SW&R Monthly Report – February 2015:

o Mr. Minor referenced data provided and slides and moved on to March 2015 data.

B. SW & R Monthly Report – March 2015:

- o Mr. Minor presented data results from March 2015.
 - Substantial increase in Class 3 compared to 2014. Higher Class 2 disposal indicates 3-2-1 process is working
 - There was a 400 ton increase in curbside collection
 - o Hauling costs have increased compared to 2014
 - 630 ton disposal increase overall (economy improves; growth; former commercial accounts for condos may be using roll carts)
 - o Disposal for March 2015 notes a 17% increase
 - o 75% of the FY complete, we are at 73/76% of budget with big months ahead
 - o Convenience Centers had approximately 144,000 visits
 - o Recycling over 800 tons for March 2015

- Reference pie chart used to be 50/50. The extra 5% possible issues with contractors. Side note per additional costs from MRF on single stream. Tipping fees cheaper to landfill as single stream costly to process and oil prices down (plastic)
- Revenue back to General Fund \$106,000
- o \$147,000 YTD credits and revenues
- Recycle Market chart shared with members
- Discussion of Convenience Center traffic data from 5/18/15 meeting. We understand that some citizens are not happy with hours. Peak usage at opening and mid-day is the norm. Drops sharply after 4 PM

 - Upcoming Events Shred in Bluffton 6/13/15
 - Upcoming Events Electronics at both locations 9/12/15
 - o Ms. Madden thanked Mr. Miller and Ms. Carter for well-run events
 - April 11 Shred = 163 cars
 - May 9 Electronics = 682 cars/39.69 tons collected
 - Received SC DHEC Compost Grant (\$2,000)
 - Planning to post intern position in the Fall
 - o Newsletter on website
 - o Green Step Schools: Bluffton High and Whale Branch Elementary
 - Two teacher workshops hosted 22 teachers (initiated 8 compost programs)
 - o 39 school programs completed
 - o GAC this weekend at Hunting Island
 - Upcoming event dates are posted on the web page
- o Chairman Duryea complimented staff on great events and cordial staff

5. Unfinished Business:

A. Transfer Station Site

 Mr. Minor updated the Transfer Station is no longer an issue for consideration (see Item C). The County is still in need of a facility for collection of white goods, electronics, household hazardous waste and other special waste streams. The approved Solid Waste Management Plan will require revision as it reflects citing a Transfer Station.

B. Usage of Beaufort County convenience centers by non county residents.

• Mr. Minor indicated project is on hold until FY2016 funds are available.

C. Disposal Contract Negotiation with Waste Management for Hickory Hill Landfill

 Mr. Minor reported that County Council accepted Waste Management's proposal which lowers our tip fee and extends our disposal contract with Hickory Hill for 10 years. The proposal also specifies that Waste Management will reveal by 2019 to the County their plans to either expand or build a transfer station at the Hickory Hill site.

D. Curbside Waste and Recycling Collection

- o Discussion of Draft MEMORANDUM from the Board to support curbside collection.
- (See attachment 1 draft resolution from the Solid Waste Board)
- Meetings with Town of Bluffton and City of Beaufort to use contracts for expansion of curbside service into POA/unincorporated areas
- o MS4 requirements will most likely impact several Convenience Centers

- o Meeting planned for June 23, 2015 to meet with waste haulers
- Sun City residents in Jasper County are using County Centers at our expense
- Ties with SC DHEC goal of 40% recycling by 2020
- o Liaison Vaigneur agreed that curbside moves County toward sustainability
- With "pay a little more" per disposal, we must increase diversion (recycling)
- We cannot continue collect volumes in Centers (3,200 in 10 hours 1/2/15)
- o Ms. Scott requested information per rural areas and curbside: roll cart to street
- Mr. Minor stated, 'With continued growth, building more Convenience Centers concept would go against the course of action that has been adopted by every progressive community in this country'
- If we truly view ourselves as a special community and environment, we need to keep trash out of our waterways vs 145,000 people self-hauling
- Chairman Duryea proposed to use Draft MEMO with addition of background facts and anticipated final version for the Facilities Committee and County Council by July 23, 2015. Ms. Corley motioned and Mr. Wheatley seconded. All approved
- Educational meetings will be initiated with HOA groups and civic groups



Solid Waste Hauling and Disposal Budgets Status






