A. SW & R Monthly Report – August 2015:

o Mr. Minor referenced data provided and moved to September 2015, as information was inclusive in second report

B. SW & R Monthly Report – July 2015:

o Mr. Minor referenced the data provided. Reminder that incoming data runs about a month behind. 3-2-1 system continues to show progress. No surprises on Solid Waste District breakdown. Pulls increase remain due to packer truck maintenance. Hauling costs are on the increase but disposal lower due to lower tipping fees

- o Traffic numbers continue to rise at several Convenience Centers; others steady
- o Recycling numbers remain in question. Numbers received from haulers higher that report data (especially District 1 and 3). Reported activity from Convenience Centers
- o Revenue collected goes to General Fund. Revenue is down
- o Copy of Market numbers in hard copy data to attendees

 Shreds Events in Beaufort and Bluffton were well attended...591 total cars. Future Event dates on website. Mr. Olson discussed upcoming Electronics Event on 12/5/15 and the Bluffton Christmas parade logistics

- o Beaufort County internal office recycling is doing well; roll carts purchased for paper
- o Compost Grant from SC DHEC: Compost bins will be sold. New intern will assist with the program
- o Environmental Liaison Program (35 teachers) may serve as model for SC programs
- o Twin the Bins Grant (Edisto/Hunting Island) will have animal-proof bins
- o Oil and Tire Grants promotional items pending
- Keep Beaufort County Beautiful Board is working hard for grants to be used in beautification projects, additional kayak cleanups and Spanish Moss Trail
- o Coastal Kingdom will have a feature on the new Whale Branch nature trail/bridge
- o Adopt a Highway Five new groups












