- 1. Call to Order: Chairman Duryea called the meeting to order at 2:03 pm
 - A. Agenda: Chairman Duryea requested a motion to approve the agenda. Vice-Chairman Uehling motioned, Ms. Corley seconded. All approved the agenda.
 - **B.** Minutes: Chairman Duryea requested a motion to approve the January 26, 2017 minutes. Vice-Chairman Uehling motioned. Ms. Corley seconded. All approved the minutes.
- 2. Introductions: All attendees introduced themselves.
- 3. Public Comment: There was no public comment
- 4. Reports:

A. SW & R Monthly Report – January 2017:

- Ms. Carter advised a revised December 2016 report was available in Board packets
- o Residential tons of waste = 6,159 for January; 400 ton increase over January 2016
- YTD residential tonnage = 43,965.81 tons
- Hauling (4.54%) and disposal costs (10.97%) increased over January 2016
- 59% of hauling budget expended; 55% of disposal budget (larger than FY16 budgets)
- o January Convenience Center traffic shows 10,000 increase over January 2016
- o Recycling for January = 456.15 tons. Newsprint = 48.72 tons. Total = 504.87 tons
- Revenues YTD \$83,910.63. MRF rebates steadily increasing

B. Recycling Events and Convenience Center Updates:

o Ms. Jenkins reported on the 2/18/17 Electronics Event (91 tons/1,249 vehicles) and the

- 3/4/17 Household Hazardous Chemical Event had 370 vehicles
- o Ms. Carter reported on the Palmetto Pride Depot Road Beautification project; 26 Sioux crepe myrtles planted; great collaboration government and volunteers
- Ms. Jenkins advised of several upcoming events: SC DHEC 'Don't take a Vacation from Recycling' billboards, 2017 Compost Bin sales (\$50) and the April 22, 2017 County-Wide Litter Clean-Up Day

5. Unfinished Business:

A. Curbside Waste and Recycling Collection

- o Mr. Minor reminded all of the efforts to move the curbside resolution forward with municipal and association meetings, surveys and two District 9 public meetings on 3/22/17 with consultant Abby Goldsmith
- Ms. Goldsmith's slide presentation was repeated. Goal is mandatory curbside service by 2020. Convenience Centers to be phased out from garbage collection and four centers used as expanded recycle centers
- o Workshop to review ordinance changes; lengthy process

B. Hurricane Matthew - Debris Removal Overview

- o Mr. Minor reported land-based removal is finishing this week with exception of Daufuskie stumps. April 2 is FEMA cut-off for funding
- o Debris Management Sites are being restored
- Extension is pending from FEMA per marine debris removal. 5 of 13 vessels have been pulled from Palmetto Bay Marina and Hwy 21/Lady's Island with 8 pending. 7 additional to be vetted within the next 45 days
- o Marine removal of vessels and dock debris is difficult, slow, labor intensive work; work directly impacted by tides. County boat landings utilized for unloading
- o Chairman Duryea commended staff efforts and FEMA coordination throughout Hurricane Matthew response

o Contact has been made with District 2 without response

- o Mr. Jim Lewis (May River Disposal) stated that curbside has been implemented in many areas of the country and is most successful when private industry and government work together. 












