

- RECYCLABLES listed to the right.
- BAGGED HOUSEHOLD GARBAGE.
- YARD TRIMMINGS (leaves, limbs and branches up to 6 inches in diameter and 4 feet in length).
- MISCELLANEOUS BULKY ITEMS (furniture, toys, other large household items).

What IS NOT accepted?

More to Know ...

- COMMERCIAL SOLID WASTE: The use of any Beaufort County Convenience Center for the disposal of commercially generated waste is strictly forbidden by Beaufort County Ordinance 62/30 and is considered illegal dumping.
- CONSTRUCTION AND DEMOLITION (C&D) DEBRIS: Small amounts of residential C&D debris (lumber scraps, sheet rock, shingles, wallboard and plaster) can be taken to the Bluffton, Shanklin and St. Helena Convenience Centers ONLY. Beaufort County residents north of the Broad River can take large quantities of C&D debris to Barnwell Resources on Lady's Island. Beaufort residents south of the Broad River can take C&D debris to the Oakwood Landfill in Ridgeland. Convenience center attendants can provide you with directions to these facilities.
- OYSTER SHELL RECYCLING: Oyster shells are collected at the Shanklin Convenience Center, the Sands in Port Royal and Hunting Island. Dump the loose shells in the collection area.
- SPECIAL WASTE: Electronic waste and hazardous household waste are taken at annual events. For a list of upcoming collection dates, visit www.bcgov.net/recycle.
- ALL MATERIAL brought to convenience centers is limited to one pick-up truck or one trailer (measuring 5 feet by 8 feet). Limit two loads per household per day.
- USED MOTOR OIL AND FILTERS: The following petroleum products ARE ACCEPTED and may be put into the used oil collection tank: motor oil, hydraulic fluid, gear oil, diesel fuel, fuel oil, kerosene, automatic transmission fluid, power steering fluid and heating oil. The following petroleum products ARE NOT ACCEPTED at Beaufort County Convenience Centers varsol, brake fluid, paint thinner, refrigeration oil, antifreeze and solvent, cleaner or any substance used to clean paint brushes. Call (843) 255-2736 for disposal options.
- YARD TRIMMINGS are accepted at all Beaufort County
 Convenience Centers in small amounts only. Larger amounts must
 be taken to the Oakwood Landfill, Barnwell Resources or Green
 Space.
- COVER YOUR LOAD! An uncovered or spilling load from your vehicle is a violation of S.C. law and is subject to fines.
