#### CALL TO ORDER

Chairman Steve Wilson called the meeting to order at 2:10 p.m.

#### **REVIEW OF MINUTES**

Chairman Wilson asked if there were any changes to the Minutes from the January 13, 2015, Board meeting. Hearing none, Vice-Chairman Stanford made a motion and Ms. Humphrey seconded the motion to accept the Minutes from the January 13, 2015 Board meeting. The motion was carried unanimously to accept the minutes from the January 13, 2015, Board meeting (FOR: Bridgwater, Diercxsens, Humphrey, Hunter, Novak, Stanford, Theodore, Wilson).

#### **GENERAL DISCUSSION**

#### <u>Belfair Update</u>

Mr. Jim Tiller stated that all SCDOT encroachment permits for the Belfair medians had been obtained and the MOU (Memorandum of Understanding) between Belfair and Beaufort County had been signed. Therefore planting of the Belfair medians was ready to begin. Mr. Tiller introduced Mr. Joe Bryant with Belfair who will be handling the planting of the medians.

Mr. Bryant stated that Belfair ended up bidding out the project and received three bids. Of the three bids they selected Valley Crest Landscaping. Work is scheduled to begin around April 15<sup>th</sup> and should be done within two to three weeks. Chairman Steve Wilson said he would like to have some recognition about this project in the media soon. Ms. Allison Coppage suggested that the Board get in contact with Monica Spells with Beaufort County for media questions. Chairman Wilson also asked Ms. Amanda Flake is she would get the Board on the agenda for the next Natural Resources Committee meeting on April 6, 2015.

Ms. Coppage informed the Board that in the SCDOT encroachment permit Beaufort County requested a waiver to not require lane closures on Hwy 278. Valley Crest submitted a safety plan that shows no lane closures and they are waiting on approval from SCDOT.

## **Board Liaison for County Council**

Chairman Wilson and Vice-Chairman Stanford had a conversation and decided it would be best if there was a Board member that could be a liaison for County Council. The liaison would try and attend County Council meetings and keep them informed of Board projects. The Board members selected Vice-Chairman Stanford as the Board liaison. Vice-Chairman Stanford will defer to other available Board members when he cannot attend meetings.

#### Signage Discussion

Chairman Wilson suggested that having some signs erected along Highway 278 to recognize those entities involved with planting the medians might be beneficial to the goal of this Board. However, after much discussion the Board decided to table this idea for now and work on other methods of recognition, like the Beaufort County Channel or Beaufort Gazette.

#### Tanger Update

Ms. Coppage finally received a response from Tanger with help from some of the Board members. Mr. Tiller has submitted the SCDOT encroachment permit and is waiting on a response. Ms. Coppage is putting the final touches on the MOU between Tanger and Beaufort County. Once the encroachment permits are obtained, Tanger can bid out the project.

#### **Budget Update**

Chairman Wilson stated that at this time asking for money from the Beaufort County General Fund is not an option. Other opportunities are the Beaufort County Tree Reforestation Fund and possibly State or Local A-Tax Funds. After some discussion it was decided that Ms. Coppage would do some research about the different A-Tax Funds and make a presentation at the next Board meeting with a recommendation of which A-Tax Fund would be best to apply for this Board.

#### **Miscellaneous**

Chairman Wilson and Vice-Chairman Stanford met with Mayor Sulka and Mr. Mark Orlando to educate them about this Board. Mayor Sulka and Mr. Orlando invited them to come to the next Town of Bluffton Beautification Committee Meeting to do a presentation about this Board. Chairman Wilson will report on this presentation at the next Board meeting.
