CALL TO ORDER

Chairman Steve Wilson called the meeting to order at 2:08 p.m.

REVIEW OF MINUTES

Chairman Wilson asked if there were any changes to the Minutes from the February 4, 2016, Board meeting. GENERAL DISCUSSION

JK Tiller Contract/Rose Hill Update

Mr. Tony Criscitiello stated that Mr. Josh Gruber, Beaufort County Deputy Administrator, had decided to place the JK Tiller contract on the Natural Resources Committee agenda for March 22, 2016 for a vote. Chairman Steve Wilson encouraged all Board members to attend this meeting if possible.

Tanger Update

Ms. Allison Coppage stated that as of Wednesday, March 7, 2016, she had a signed and fully executed landscape maintenance agreement between Tanger and Beaufort County. This agreement includes the following items:

- 1. A check to Beaufort County for the landscape bond in the amount of \$323,865.00.
- 2. Beaufort County will install and maintain the landscape for five years.
- 3. After five years Tanger will take over maintenance of the landscape in perpetuity.

Ms Coppage said that she was in the process of setting up a meeting to get a design/build out for bid. Included in the bid will be the detailed design, installation, encroachment permit, and supervision of project. She will let the Board know when this project will go out for bid. The Board requested that they be able to review the contract before it gets final approval so they can advise County Council that the bid is in compliance with the standards set by the Board.

Maintenance Standards

Vice-Chairman Glenn Stanford passed out the second version of the maintenance standards designed by the subcommittee. These standards were based off of SCDOT standards and then revised by the subcommittee. Vice-Chairman Stanford reviewed all the standards with the Board members. Vice-Chairman Stanford made a motion and Mr. Tray Hunter seconded the motion to accept the second revision of the maintenance standards as amended and advise the County to recommend them as the standards of the Board. The motion was carried unanimously to accept the second revision of the maintenance standards as amended and advise the County to recommend them as the standards of the Board (FOR: Bridgwater, Diercxsens, Hunter, Novak, Stanford, Theodore, Wilson).

Hwy 170 Discussion

Ms. Sallie Bridgwater was approached by the Executive Director of Sun City who wanted to know what was going to be done about the lack of vegetation along Hwy 170. Their understanding was that no trees would be removed in their road buffer. However, during construction many trees were removed and now it is very noisy to Sun City residents. Sun City would like to know what could be done to fix their buffer. Could they plant the buffer, entrances, and medians? After some discussion it was suggested that Ms. Bridgwater, Mr. Hunter, and Vice-Chairman Stanford attend one of Sun City's Board meetings and discuss what the Board has done so far and give them some ideas of how they can fix their buffer. This group will report on their findings at the next Board meeting.

Miscellaneous

Mr. Jim Fearon, a resident of The Crescent, attended the Board meeting and asked the Board members if he would be able to mow the median in front of The Crescent on Hwy 278. The Board suggested the Mr. Fearon contact SCDOT since the median is under SCDOT jurisdiction.
