GENERAL DISCUSSION

Maintenance Standards Update

Vice-Chairman Glenn Stanford presented an updated version of the maintenance standards. The Board made a recommendation to send these standards to the Planning Department to be used for any new median landscape projects. Mr. Tony Criscitiello will give an update next month about how this request will be processed by the Planning Department.

Tanger Update

Ms. Allison Coppage stated that she had received \$323,865.00 from Tanger and is currently working on a bid. She is hoping to have plants in the ground by September or October.

Hwy 170 Issue

Ms. Amanda Flake received information from the Beaufort County Engineering Department that Sun City was paid for the taking of their right-of-way easement along Hwy 170. Specifically the Sun City Hilton Head Community Association received \$565,310.00 and Del Webb received \$283,010.00. Therefore Vice-Chairman Glenn Stanford, Ms. Sallie Bridgwater, and Mr. Tray Hunter will visit Sun City representatives to discuss this matter and report back to the Board at the next meeting.

Moss Creek Partnership Discussion

Postponed until next month.

Board Members Communication with County Council

Chairman Steve Wilson would like to encourage all Board members to stay in contact with their County Council members to keep them up to speed with the current status of this Board. Ms. Sallie Bridgwater talked with County Councilman Jerry Stewart and he suggested that the Board should be more involved with the bid contracts. After some discussion by the Board members, it was suggested that Councilman Stewart be invited to the next Board meeting to explain his view of the role of this Board.

JK Tiller Contract/Rose Hill Update

Mr. Tony Criscitiello stated that he had a discussion with Finance on how to proceed with bidding new projects. It was decided to lump together the Tanger bond, Jazz Development bond, and the Tree Reforestation money and do one large bid for all of these projects. Mr. Criscitiello is working with Finance to get a list of companies that could do a design/build bid using JK Tiller's Landscape Plan as a base. Vice-Chairman Stanford and Mr. Todd Theodore would like to see a third party supervise whoever gets the contract to install and maintain the plants. Mr. Criscitiello will bring back language to the Board for review at the next meeting.
