GENERAL DISCUSSION

Landscape Median Bid Update

Mr. Tony Criscitiello stated that Beaufort County Planning Staff had developed a bid proposal for the section of Hwy 278 from Belfair to Rose Hill. Mr. Jim Tiller had been hired to develop landscape drawing specifications for this area. The County staff is still waiting to receive those plans. The County Planning Department will have a new planner on board next month who has landscape architecture experience and will eventually be overseeing these projects.

Role of the Board

Chairman Steve Wilson stated that at the last Board meeting County Councilman Jerry Stewart conversed with the Board about the role of the Board and funding sources for the Board. It was conveyed by Councilman Stewart that the bulk of the budget for this Board would be through solicitation of private funds which the Board was not willing to do since Board members were volunteers. Councilman Stewart then suggested that someone from the Board inform the Natural Resources Committee about this decision so the future of the Board could be discussed. Vice-Chairman Stanford and Ms. Sallie Bridgwater volunteered to attend the next Natural Resources Committee Meeting on June 21, 2016.

Sun City Update

Ms. Bridgwater stated that the Sun City management company had been released of their duties and until a new management company was hired this discussion will be postponed.
