CALL TO ORDER

Chairman Steve Wilson called the meeting to order at 2:00 p.m.

REVIEW OF MINUTES

GENERAL DISCUSSION

Landscape Median Bid Update for Rose Hill/Belfair

Ms. Nancy Moss reported that the landscape bid for Rose Hill/Belfair was posted on December 13, 2016. It was advertised in the Island Packet and State Newspapers yesterday. The pre-bid meeting will be on January 4, 2017 and the bid is due on January 26, 2017.

Tanger Update

Mr. Tony Criscitiello stated that there was about \$360,000 earmarked for the Tanger Project in a separate account. This money was strictly to be used in the medians in front of the Tanger Outlets on Hwy 278. After some discussion by the Board members, Vice-Chairman Glenn Stanford made a motion and Ms. C.J. Humphrey seconded the motion to implement hiring a landscape architect to design the median landscape plan for the Tanger Project. **The motion was carried unanimously to implement hiring a landscape architect to design the median landscape plan for the Tanger Project** (FOR: Boehme, Bridgwater, Diercxsens, Humphrey, Hunter, Stanford, Wilson).

Finance Committee Meeting Update

Vice-Chairman Stanford said that Mr. Criscitiello made a great presentation to the Finance Committee about the Rose Hill/Belfair median project and got approval for \$100,000.00 from the Tree Reforestation Fund. Vice-Chairman Stanford received questions from committee members about how the Board was fundraising for projects. He stated that the Board had researched state grant sources and at this time there were no grants available. The Board had also approached the Town of Bluffton and the Town of Hilton Head whom both expressed interest but had no funding currently available. Chairman Steve Wilson stated that his understanding of fundraising was that the Board would find some private funding and Mr. Kubic would try to match that funding. Mr. Randy Boehme said that he would reach out to Bluffton Mayor Lisa Sulka and Town of Bluffton Manager Mark Orlando to see if the Town of Bluffton could help the Board. Mr. Criscitiello reported that at the next Natural Resources Committee Meeting there would be a project presented to rezone the Hilton Head National Golf Course. This project would probably involve some new landscaping. Vice-Chairman Stanford suggested that someone from the Board should attend this meeting and request that this project come under the purview of this Board for landscaping requirements. Ms. Amanda Flake stated she would add the Board members emails to the monthly notification list for the Natural Resources Committee and Finance Committee meetings.

Miscellaneous

The Board members discussed inviting the Moss Creek Representatives to the February Board meeting. Ms. Flake will send Mr. Wallace Milling and Mr. John Miller an invitation for the February Board meeting.

Ms. Sallie Bridgwater made a motion and Vice-Chairman Stanford seconded the motion to add the median section east of the Tanger Outlet to the first plantings at Moss Creek to the overall Tanger Project.
