CALL TO ORDER:

Chairman Glenn Stanford called the meeting to order at 2:05 p.m.

REVIEW OF MINUTES:

Chairman Stanford asked if there were any changes to the Minutes from the February 15, 2018, Board meeting. Hearing none, Mr. Novak made a motion and Ms. Bridgwater seconded the motion to accept the Minutes from the February 15, 2018 Board meeting. **The motion was carried unanimously to accept the minutes from the February 15, 2018, Board meeting** (FOR: Boehme, Bridgwater, Brown, Novak, Stanford and Theodore).

GENERAL DISCUSSION

Landscape Median Project Update for Rose Hill/Belfair:

The landscaping continues to be maintained by Brightview. A small fire burned 23 junipers near the Rose Hill traffic signal, so the County authorized Brightview to replace the damaged plants and pine straw mulch for \$346.

Tanger Median Landscape Update:

The County Council approved the Community Development Department's recommendation to select the lowest bidder, Hilton Head Landscape, for this project. No objections were filed by the other two bidders. Beaufort County hopes to issue a "Notice to Proceed" by April 1st. Chairman Stanford said that this is by far the most visible project segment to date. The low bid was approx. \$50 less than the budget and it would be best to reserve expenditures of the surplus funds until the Tanger project is near completion.

Recognition of Steve Willson's Beautification Efforts:

Glenn Stanford met with Mrs. Pat Wilson and presented her with the accommodation letters prepared by the Board and by Tony Criscitiello for Steve Wilson's Beautification efforts. Mrs. Wilson expressed her deep appreciation for the recognition of Steve Wilson's work.

Berkeley Hall Median Landscaping Update:

The plans were approved by SCDOT November 2017, but this project lacks a funding source in order to move forward.

Funding Sources & Strategy for Renegotiated Bluffton Development Agreements:

Chairman Stanford would like to see The Town of Bluffton set funding aside for landscaping on Highway 170 as a tool of the Development Agreement Renegotiation. Chairman Stanford would like to meet with the Town Manager and Mayor to express this Board's thoughts on this. The Bluffton Town Manager and Mayor have each indicated that they fully support this Board's Beautification efforts. Mr. Boheme schedued an informal discussion with Town officials. Mr. Greenway said that he would discuss this matter with the Bluffton Mayor at the upcoming Southern Regional Plan meeting.

The Board members were asked to review the State of Georgia's funding source material that Chris Inglese sent to the Board and determine whether it would be applicable to the State of South Carolina.

ADJOURNMENT

With no further business, Chairman Stanford entertained a motion at 3:10 p.m. from Vice-Chairman Novak, and seconded by Ms. Bridgwater, to adjourn the meeting. The motion was approved unanimously (FOR: Boehme, Bridgwater, Brown, Novak, Stanford, Theodore).
