## V. Old Business:

- A. **Ashley Furniture Conceptual Architecture:** Staff presented the project report. Darren Watson, project architect was present to discuss the project. The Board made the following recommendations:
  - 1. The building roof line should have variation.
  - 2. The sign cupola looks like a billboard, is overstated, detracts from the overall building and must be removed as designed.
  - 3. Show the doorways on rear elevations.
  - 4. Consider roof overhangs and canopy extensions to break down the overall scale/mass of the building.
  - 5. The proposed architecture is monotonous and does not blend with the surrounding community. Redesign so it blends with the surrounding community.

- 6. Redesign the overall structure to break up the building so it looks like several structures as opposed to one structure.
- 7. Consider color variations to help break up the façade.
- 8. The Board cannot fully evaluate the rear building elevation with the site plan. The site context is key to the building design and location.
- 9. The Board stated the rear elevation of the building will need attention as it is the front door to the Fairfield Inn.

## VI. Other Business:

- A.
