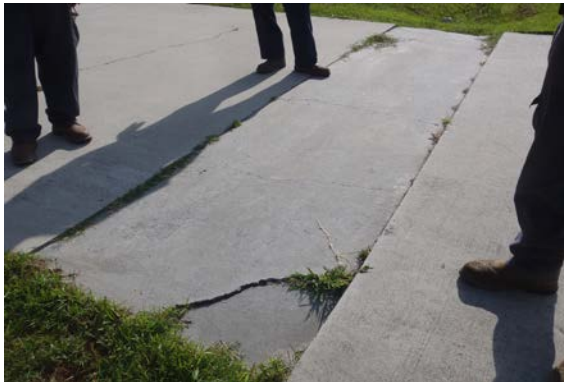
**Narrative Description of Project:**

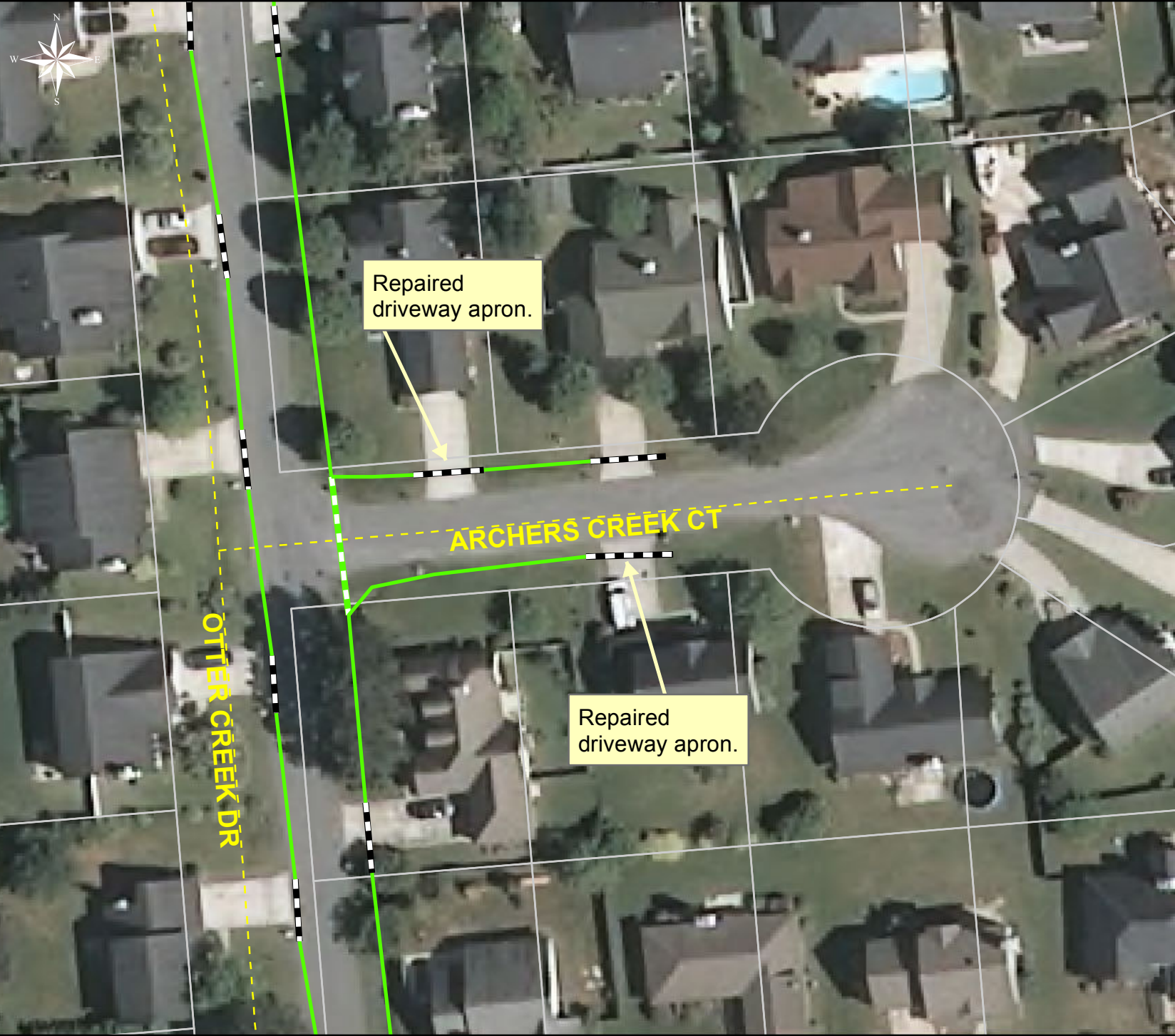

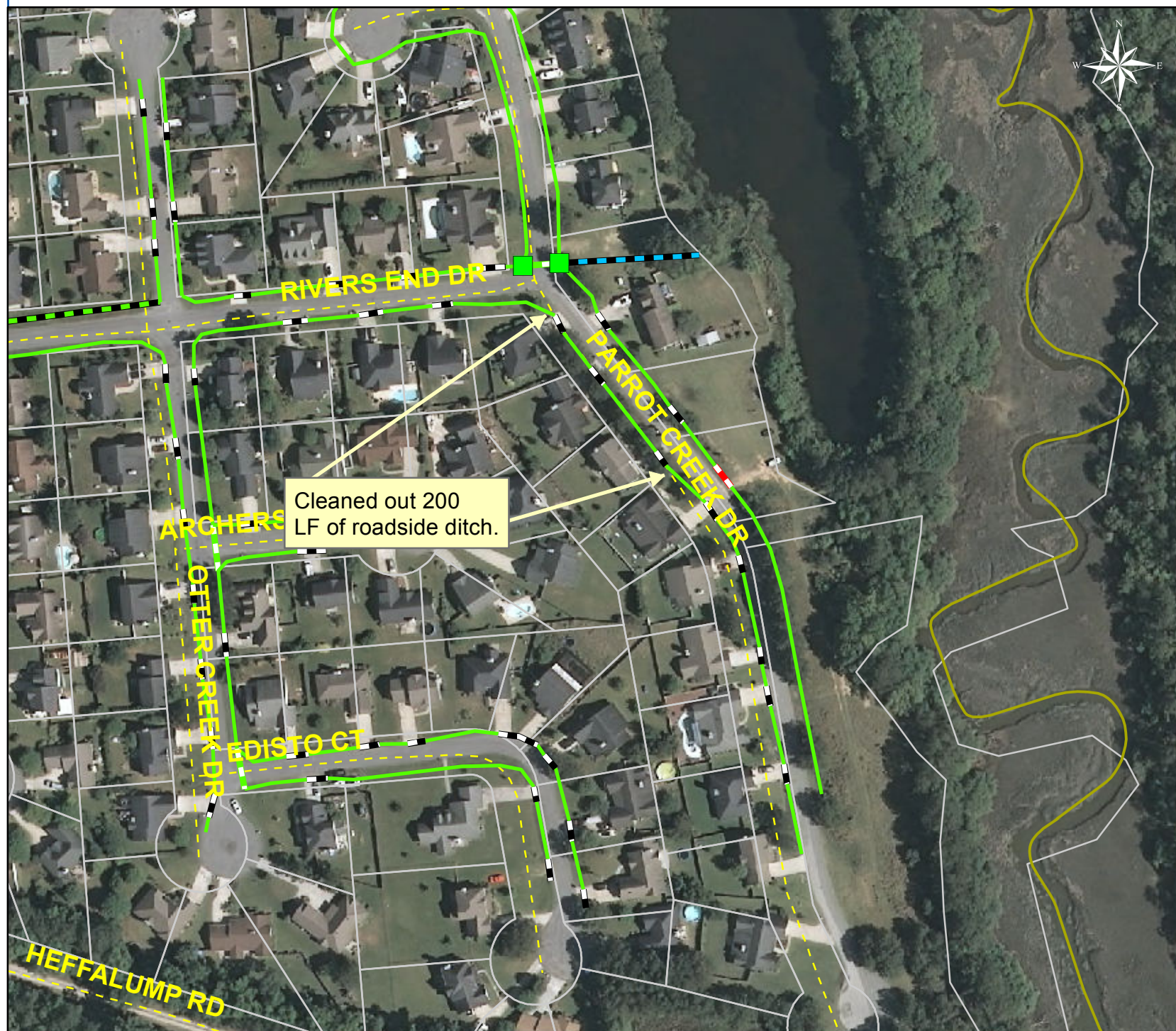
