Tuesday, June 9, 2026 7:00 AM - 7:00 PM -- Statewide Primary Election

The polls open at 7:00 AM for voting in the Statewide Democratic and Republican Primary election. The Board of Voter Registration and Elections of Beaufort County would like to remind voters South Carolina does not register by party, however voters will be asked "In which party's primary do you wish to vote in?"

Wednesday, June 10, 2026 at 10:00 AM -- Hand-count Audit

The Board of Voter Registration and Elections of Beaufort County will conduct a hand-count audit on Wednesday, June 10, 2026 at 10:00 am. The purpose of a hand-count audit is to ensure the number of ballots cast was accurately recorded by the tabulation device. Additionally, the audit ensures that the number of votes cast for a particular candidate was accurately recorded by the tabulation device.
