

Statement of Intention of Candidacy & Party Pledge

- The Statement of Intention of Candidacy & Party Pledge (SICPP) must be completed by any candidate seeking a political party's nomination and filed with the appropriate election commission.
- The "name as it is to appear on ballot" may be a given name or a derivative. The name may not contain quotations, parentheses, or other distinguishing marks. Nicknames are allowed if they are used in good faith for honest purposes and do not imply professional or social status, include an office or military rank, or exceed 15 letters.
- The S.C. Constitution prohibits a person who has been convicted of a felony from filing for public office for 15 years after the completion of the sentence, including probation and parole time, unless previously pardoned.
- The candidate must sign in the presence of an election commission official or Notary Public.
- Candidates are also required to separately file a Statement of Economic Interests and a Campaign Disclosure online with the State Ethics Commission. Failure to file these reports may result in candidate fines. Candidates are not required to file copies of these documents with the election commission. I hereby affirm that I meet, or will meet by the time of the general or special election, or as otherwise required by law, the qualifications for this office.</p>
