Pending Elections

- ☐ Hilton Head Island Ward 3 Special Election
 - Filing period: December 10 20, 2011
 - Election date: February 15, 2011
 - Must win by majority vote...runoff date: March 1
- ☐ Fripp Island PSD Special Election
 - Filing period: December 10 20, 2011
 - Election date: February 15, 2010





Precinct "Housekeeping"

- □ Opportunity to shore up a few areas in advance of the release of the Decennial census data
- ☐ Why?
 - Will allow us to reduce voter numbers in at least two precincts to a size not exceeding codified limits
 - Right-sizes critical precincts into more manageable sizes for reapportionment
- ☐ This is not reapportionment
 - Voters will not move between political districts
 - Basic footprint of precincts will remain the same






Option 1


- ☐ Split Sun City 4B
 - ☐ Current size = 3,012 voters
 - Recommend splitting 3 ways
- Consolidate HH 8A and HH 8B
 - □ 334 and 680 voters respectively
 - Precincts are contiguous
 - \Box Combined total = 1.014 voters
- Consolidate HH 6B and HH 7A
 - □ 558 and 726 voters, respectively
 - Precincts are contiguous
- Split Bluffton 2C
 - □ 2,069 voters


Option 2

- Split Sun City 4B
 - ☐ Current size = 3,012 voters
 - ☐ Recommend splitting 3 ways
- Consolidate HH 8A and HH 13
 - ☐ 334 and 812 voters respectively
 - Precincts are contiguous
 - Both beach-front communities with shared HOA
 - Both are in Ward 4
 - ☐ Combined total = 1,146 voters
- Consolidate HH 6B and HH 7A
 - 558 and 726 voters, respectively
 - Precincts are contiguous
- ☐ Split Bluffton 2C
 - □ 2,069 voters












HILTON HEAD 8A, 8B and 13













HILTON HEAD 6B and 7A










