




### Consolidate HH8A and HH 13





### S. 1 - Election Reform Act

- Primary purpose(s):
  - Establish early voting
  - Require photo ID
  - Modifies absentee process
- Concerns:
  - Limits absentee polling locations to one
  - Unfunded mandate re: early voting center(s)
- Sponsor(s):
  - Campsen, McConnell, Leatherman, Peeler,
     Shoopman, Rose, Cleary, Verdin, S. Martin, Massey,
     Fair and Davis
- Status:
  - Jan 12 referred to Senate Judiciary subcommittee

#### S. 209 - Absentee Qualifications

- Primary purpose(s):
  - Allows no-excuse absentee voting
  - Allows absentee application process to be completed on line
- Concerns: None known
- Sponsor(s): Lourie
- Status:
  - Jan 11 Referred to Senate Judiciary Comm.

#### S. 333 - Notice of Death

- Primary purpose(s):
  - Coroner must provide notice of death to CEC
  - Funeral directors must provide notice of death to CEC
- Concerns:
  - Requires CEC to "prescribe forms for transmission of names of deceased persons" to state
- Sponsor(s): Massey
- Status:
  - Jan 11 Referred to Senate Judiciary Comm.

### S. 404 - SC UOCAVA Act

- Primary purpose(s):
  - Allows absentee voters in OS isolated areas to submit a federal write-in absentee ballot for any federal, state, or local office or ballot initiative
  - Requires electronic free access ballot tracking system
  - Waives witness requirement for <u>all</u> UOCAVA voters
- Concerns: None
- Sponsor(s):
  - Campsen, McConnell, Davis, Leventis, Matthews, L. Martin, Massey, McGill, O'Dell, Pinckney, Rankin, Reese, Rose, Ryberg, et al

#### Status:

Jan 20 - Referred to Senate Judiciary Comm.

#### H. 3003 - Photo ID / Absentee Voting

- Primary purpose(s):
  - Requires photo ID
  - Definition of "Domicile" given greater fidelity
  - Absentee application requests mail or walk-in only
  - Retains witness signature requirement on absentees
  - Absentee voting becomes paper only
- Concerns:
  - Restricts absentee application request process
  - Eliminates in-person absentee voting
- Sponsors:
  - Clemmons, Lucas, Bingham, Harrison, Cooper,
     Patrick, Erickson, et al
- Status: Jan 25 Request for floor debate

### H. 3110 - Registration by Party

- Primary purposes(s):
  - Requires registration by party
- Concerns: Uncertain
- Sponsors:
  - G.R. Smith, Thayer, Hamilton and Long
- Status:
  - Jan 11 Referred to House Judiciary Comm.

### H. 3349 - Overseas Absentee Voting

- Primary purpose(s):
  - U.S. citizens who have never lived in the U.S., but whose parents are registered in SC, may register to vote where the parents are qualified electors . . . If they are not otherwise registered
- Beaufort County concerns: Uncertain
- Sponsors:
  - Clemmons and Sellers
- Status:
  - Jan 19 Referred to House Judiciary Comm.

# H. 3392 - Multi-faceted (S. 391)

- Primary purpose(s):
  - Establishes standing protocol for make-up elections
  - Opening absentee ballots may begin at 9 am
  - Accelerates party primary submissions to CEC and SEC from April 9 to April 5
  - Presidential/VP candidates must be certified to SEC NLT 1st Tues following 1st Mon in Sept
- Concerns:
  - 1 week between election and make-up day
- Sponsors: Clemmons and Sellers
- Status: Jan 20 Referred to House Judiciary Comm.
